The shareholders can login for remote e-voting, e-voting during the AGM as follows: the individual shareholders cholding shares in demat can login through CDSL Easi/ Easiest facility or NSDL IDeAS facility or logging through their Depository Participant; the shareholders holdingin physical and non-individual shareholders can login through e-voting website www.evotingindia.com using their DPID/ Client ID or Folio No. along with PAN of e-voting code as provided by the Company/RTA. Detailed instructions/procedure are provided in the Notice of the AGM, Members whose email addresses are not registered with the Company's RTA/Depositors, may generate login credentials by following instructions given in the Notes section to Notice of the AGM.
