In compliance with the MCA and SEBI circulars, the Company has completed the dispatch of Notice of AGM along with Annual Report of the Company for the financial year 2023-24 along with login details for joining the 19th AGM through VC or OAVM as on Monday, August 12, 2024, through electronic mode to those members whose email addresses are registered with the Company/ Depository Participants (s) and Registrar and Share Transfer Agent- Link Intime India Private Limited ("LI IPL") as on Friday, August 09, 2024.
