## Don's U-turn: Slams Walz over Floyd case

In sharp contrast to Republican presidential nominee Donald Trump and running mate JD Vance hammering Minnesota Governor Tim Walz over his response to the violence that erupted after George Flovd's murder, an audio recording has revealed the then President Trump telling the governor at the time that he fully agreed with how Walz handled it.

"What they did in Minneapolis was incredible. They went in and dominated, and it happened immediately," Trump told Walz and other governors and officials in a phone call on June 1, 2020. The Associated Press on Wednesday obtained an audio recording of the call, which has taken on new significance now that

Walz has been tapped as Vice-President Kamala Harris' running mate against Trump and Vance. Other administration officials on the call included Secretary Mark Esper; Army Gen. Mark Milley, chairman of the Joint Chiefs of Staff; and Attorney General

William Barr.

ABC News reported on the call earlier Wednesday, a day after Harris introduced Walz as her vice-presidential pick. CNN posted a transcript of the call back in 2020. Protests erupted in Minneapolis and around the world after Floyd

was murdered by Derek Chauvin, a white former officer who knelt on the Black man's neck for nearly 9 1/2 minutes, on May 25, 2020. A bystander video captured Floyd's fading cries of "I can't breathe." His death forced a reckoning with police brutality and racism. Some of the protests turned violent.

Walz mobilized the Minnesota National Guard three days later to help restore order to Minneapolis after rioting that included the burning of a police station and numerous businesses. Trump offered federal help to Walz later that day, but the governor did not take him up on it. During a May 2024 fundraiser in St. Paul, Trump repeated a claim he had been making lately that he was responsible for deploying the National Guard. Trump made similar claims at a rally in St. Cloud last month

### **Post-riots, UK** to tweak Online **Safety Act**

**Agencies** LONDON

The British government is considering tweaks to the Online Safety Act following a week of racist rioting driven by false information online. At the same time, the government has urged police officers to remain on high alert ahead of possible further riots over the weekend.

The Act, passed in October but not set to be enforced until early next year, allows the government to fine social media companies up to 10% of global turnover if they are found in breach. At present, companies would only face a fine if they fail to police illegal content, such as incitements to violence or hate speech. Proposed changes could see Ofcom sanction companies if they allow "legal but harmful" content such as misinformation to flourish.

### **Police stations** reopen with military support in B'desh



DHAKA

Police stations in Bangladesh, which were deserted during the peak of the anti-government protests, are slowly resuming their normal activities with the assistance of the military, according to media reports on Friday.

Following the fall of the Sheikh Hasina government on Monday due to student-led protests, all police station activities came to a halt. Several police stations were attacked, looted and set on fire, leading to many officers evacuating their stations and going into hiding due to the threat of more attacks. More than 400 people, including police personnel, were killed in the violence cen-

tered around the students' movement. After about four days, activities resumed at some 29 police stations with the assistance of the military, the Dhaka Tribune newspaper reported, quoting military and police officials.

### Leave Lebanon, kin of peacekeepers told

United Nations Interim Force in Lebanon (UNI-FIL) spokesman Andrea Tenenti has said that families of the peacekeepers working with the agency must leave the country.

"Many families have left, even though some remained in Beirut where the situation was calmer," the spokesperson said, Elnashra news website reported. "The new measure concerns them as well, and it is temporary," he said. Tenenti's remarks coincided with the recent conflict escalation between Hezbollah and the Israeli army on the border in southern Lebanon, Xinhua news agency reported quoting Elnashra.

## Kerala seeks ₹2k cr for rehabilitation of victims

A day ahead of Prime Minister Narendra Modi's scheduled visit to landslide-hit Wayanad, the cabinet sub-committee of the Kerala government met with a central team visiting the area and sought Rs 2,000 crore in assistance for rehabilitation and relief work in the disaster-stricken region.

The central team, led by Raieev Kumar, who is a joint secretary with the Ministry of Home Affairs, visited the disaster-hit region and interacted with the survivors.

The inter-ministerial central team said the impact of the Wayanad landslide is huge and a detailed study is required.

The team met with the Kerala cabinet sub-committee and discussed the various rescue operations, relief camps, autopsies, handing over of bodies to relatives of the deceased, funerals, the collection of DNA samples and the details of the missing people.

(KSDMA) Dr Sekhar L Kuriakose detailed the possible reasons behind the land-

The state government, in a release, said it has informed the central team that the Chooralmala, Mundakkai and Punchiri Mattam regions of Wayanad have suffered major losses both in residential areas and in the agricultural sector.

Rs 2,000 crore is required for rehabilitation purposes alone, the state government said. Huge losses have been incurred with regard to the agriculture sector, livestock, houses, buildings, commercial establishments, roads and electricity, as well as private properties, it added, and showed the central team the drone videos of the disasterhit region.

Meanwhile, the state government said those who are in relief camps will be rehabilitated to various houses, including government quarters identified for the purpose. Minister P A Muhammad

Rivas said there are 125 houses, including government residential quarters, and most of them are ready for people to move into. Rivas said the cabinet sub-committee has

to make arrangements for the furniture and other home appliances required to rehabilitate the survivors.

He said the cleaning work in the disaster-hit regions will take at least 90 days, and the relief camps will continue to house people as long as needed.

The state government also said that the survivors will be provided cash assistance.

The cabinet sub-committee said the state government has taken a stern stand against financial institutions demanding loan repayments from disaster-struck families, and sought the intervention of the central team on this matter.

According to the latest reports, a total of 226 people lost their lives so far in the devastating landslide that happened on July 30. As many as 197 body parts have been recovered, while there are 133 people missing. Currently 78 people are in various hospitals undergoing treatment.

The government has informed that there will be no search operations on Saturday due to the prime minister's visit but they will resume on

The seizure was made following a specific input.
