
1st time in 15 yrs, India overtakes China as top source of foreign students in US

Both countries dominate US' foreign student cohort with a share of 54%

FOR THE first time since 2009, Indians have surpassed the Chineseasthe largest cohort of intentional students in the US, according to the latest Open Doors 2024 report released Monday. In 2023-24, there were 3.31 lakh Indian students in the US, making up 29.4% of its 11 lakhstrong international student population. It was 25.4% the previous cacdemic year.

Wanted for 20 years, Maoist leader killed in Karnataka encounter

MAOIST LEADER Vikram Gowda, MAUDIS LEADER VIRGAM GOWDA, 44, who had been elusive for more than 20 years, was killed in an ex-change of gunfire with Karnataka Police's Anti-Naxal Force (ANF) in Udupi district Monday night, state Home Minister G Parameshwara

Home Minister G Parameshwara said Tuesday. Gowda, who belonged to a place near Hebri in Udupi, was seen as the last standing Maoist leader from Karnataka following he arrest of BG Krishnamurthy, alias Gangadhar, 50, by Kerala Police in 2021. Krishnamurthy, who hailed from Chikkamagaluru, was a member of the Central Committee of the banned CPI (Maoist) and secretary of the Western Ghats Special Zonal Committee.

secretary of the Western Ghats Special Zonal Committee. Police sources said Gowda was visiting Kabbinale village Monday night with his team to collect groceries when the ANF, which was combing the area, came across him.

The Maoists opened fire on the ANF team and Gowda was killed in retallatory firing, Parameshwara said. "We have information that three Naxals escaped after Vikram Gowda

information that three Naxals escaped after Vikram Cowda was shot. The ANF is continuing Its searches in the region. This was the first killing of a Maoist in Kamataka in 13 years. The state government had announced a reward of Rs 3 lakh on information leading to arrest of Gowda while Kerala had announced Rs 50,000. Shimla: The Himachal Pradesh High Court on Monday ordered the attachment of Himachal Bhawan, the state's premier guesthouse at 27 Sikandra Road in New Delhi, for potential auc-tion over unpaid dues to Seli Hydro Electric Power Company. Justice Ajay Mohan Goel directed the principal secretary of the multi-purpose projects and power departments to conduct aninquity to identify the specific officer(s) responsible for failing to deposit the arbitration award amount of ₹64 crore along with seven per cent interest in the court.The high court empha-

sised that the interest amoun would be recovered personally from the guilty officers and em-

ployees.

The high court said that the inquiry be completed within 15 days and the report be submit-ted during the next hearing, on December 6. ENS
