Working on logistics of Tahawwur Rana's surrender, extradition to India :Vikram NEW YORK/AGENCY

India is working on the logistics of Tahawwur Rana's surrender and extradition from the US, Foreign Secretary Vikram Misri has said, as President Donald Trump announced that his administration has given the go-ahead to extradite the 26/11 terror attack accused "to face justice". "This is an issue on which the US authorities have taken very clear decisions. I think you've seen the President announce it himself from the White House podium the decision of the United States to extradite" Rana, Misri said at a press conference here on Thursday. During a joint press conference with Prime Minister Narendra Modi in the White House, US President Donald Trump announced that his administration has approved the extradition of "very evil" Tahawwur Rana, wanted by Indian law enforcement agencies for his role in the 26/11 Mumbai terror attacks, "to face justice in India". In response to a question on the timeframe by when Rana will be extradited to India, Misri said: "We are working on the logistics of his surrender and extradition to India."

Indians among 260 foreigners being rescued from virtual slavery in Myanmar's online scam centres

Some 260 people, including some Indians, believed to have been trafficked and trapped into working in online scam centres are to be repatriated after they were rescued from Myanmar, Thailand's army announced Thursday. In a fresh crackdown on scam centres operating from Southeast Asia, the Thai army announced Thursday it is coordinating an effort to repatriate some 260 people believed to have been victims of human trafficking after they were rescued and sent from Myanmar to Thailand. Myanmar, Cambodia and Laos, which share borders with Thailand, have come to be known as havens for criminal syndicates who are estimated to have forced hundreds of thousands of people in Southeast Asia and elsewhere into helping run online scams including false romantic ploys, bogus investment pitches and illegal gambling schemes.

Donald Trump signs plan for reciprocal tariffs on US trading partners

PARIS (AGENCY) President Donald Trump on Thursday rolled out his plan to increase US tariffs to match the tax rates that other countries charge on imports, possibly triggering a broader economic confrontation with allies and rivals alike as Trump hopes to eliminate any trade imbalances. "I've decided for purposes of fairness that I will charge a reciprocal tariff," Trump said in the Oval

Office at the proclamation signing. "It's fair to all. No other country can complain." Trump's Republican administration has insisted that its new tariffs would level the playing field between US

manufacturers and foreign competitors, though these new taxes would likely be paid by American consumers and businesses either directly or in the form of higher prices. The politics of tariffs could

easily backfire on Trump if his agenda pushes up inflation and grinds down growth, making this a high stakes wager for a president eager to declare his authority over the US economy.

लुधियाना की शादी में वेटर की ड्रेस में घुसा शस्त्र

समराला (एजेंसी) पंजाब के लुधियाना जिले के समराला के निजी पैलेस में विवाह समारोह में अज्ञात चोर वेटर की ड्रेस पहनकर पहुंचा और मौका देखते ही दूल्हे की मां का पर्स चुराकर वहां से फरार हो गया। पर्स में छेड़ लाख रुपये नकद और करीब 50 हजार रुपये के गहने थे। यह सारी घटना सीसीटीवी में कैद हो गई। इस संबंध में समराला पुलिस ने अज्ञात व्यक्ति पर मुकदमा दर्ज कर दोषी की तलाश की जा रही है। दूल्हे गुरशरणदीप सिंह निवासी भमारसी, नजदीक सरहिंद, जिला फतेहगढ़ साहिब से फोन पर बातचीत की गई तो उन्होंने बताया कि बीते दिन उनके विवाह का समारोह समराला के खन्ना रोड स्थित एक निजी पैलेस में चल रहा था। समारोह के दौरान अज्ञात व्यक्ति ने उनकी मां का पर्स चुरा लिया। उन्होंने पर्स की खोजबीन की लेकिन कुछ पता नहीं चला। पर्स में नकदी के अलावा लड़की वालों की ओर से मां को शगुन में दिए गहने भी थे। गुरशरणदीप सिंह ने इस सारी घटना का जिम्मेदार निजी पैलेस के प्रबंधक को बताया और कहा कि बैक्रेट हाल के दोनों दरवाजे खुले थे और सीसीटीवी में पता चला कि चोर वेटर के ड्रेस में आया था। गुरशरण ने कहा कि बैक्रेट हाल में जर्मेट की जिम्मेदारी बनती है कि अज्ञात व्यक्ति अंदर ना आए। उनकी अनदेखी के कारण यह घटना घटी है, इसलिए पुलिस को उनके खिलाफ कार्रवाई करनी चाहिए। समराला पुलिस के एसएचओ गुरमीत सिंह ने कहा कि अज्ञात चोर ने वेटरों जैसी ड्रेस पहनी हुई थी, जिसकी सीसीटीवी फोटो भी सामने आई है। चोरी की घटना के संबंध में पुलिस द्वारा अज्ञात व्यक्ति पर मुकदमा दर्ज कर लिया है और दोषी की तलाश की जा रही है।

नोएडा पुलिस और चोरों के बीच हुई मुठभेड़

नोएडा (एजेंसी) नोएडा के थाना सेक्टर 49 की पुलिस बीती देर रात सेक्टर 50 नोएडा जाने वाली सड़क पर सीजेन प्लॉट के पास चेकिंग कर रही थी। इसी दौरान दो चोरों के साथ मुठभेड़ हो गई। पुलिस ने मोटरसाइकिल पर सवार दो साइडिंगों को रोकने का इशारा किया, लेकिन वे भागने लगे और पुलिस पार्टी पर जान से मारने की नियत से फायरिंग की। पुलिस ने जवाबी कार्रवाई की, जिसमें एक आरोपी गोली लगने से घायल हो गया। पुलिस ने घायल आरोपी को पहचान शहजाद (28 वर्ष), निवासी गली नंबर 1, डासना, थाना मसूरी, जिला गाजियाबाद के रूप में की, जबकि दूसरे आरोपी को काबिम के दौरान गिरफ्तार कर लिया। दूसरे आरोपी को पहचान वाजिद (34 वर्ष), थाना मसूरी, गाजियाबाद के रूप में हुई। पुलिस ने आरोपियों के कब्जे से एक देसी तमचा, एक जिंद कारतूस, एक खोखा कारतूस .315 बोर, चोरी की मोटरसाइकिल, एक मोबाइल और आधार कार्ड बरामद किया। घायल आरोपी को उपचार के लिए अस्पताल भेजा गया। फूटपल में आरोपियों ने बताया कि उन्होंने सेक्टर 52 मेट्रो स्टेशन के पास एक व्यक्ति से मोबाइल फोन चोरी किया था और बरामद मोटरसाइकिल तीन-चार दिन पहले सलापुर से चुराई थी।
