Meet on Indo-Bangla water sharing scheduled for Aug 25

NEW DELHI: Ahead of Bangladesh Prime Minister Sheikh Hasina's visit to India, a ministerlevel meeting of the Bangladesh-India Joint Rivers Commission is scheduled on August 25, sources said. No official comment has been made by the government but sources said water-sharing treaties of the Teesta and other rivers may be discussed in the meeting. Bangladesh PM Sheikh Hasina is expected to travel to India on September 5 on a three-day visit during which defence cooperation and regional stability are likely to be the focus of the talks with her Indian counterpart Modi, an official said on Monday.

Assault weapons found in Raigad were AK-56s: Police

ALIBAUG: The three assault rifles found on board an unmanned yacht in the Arabian sea in Maharashtra's Raigad district recently were AK-56 rifles, local police said on Monday and added 247 bullets were also seized. Officials had earlier said three AK-47 rifles were found on board the yacht. The 16-metre-long yacht named 'Lady Han' was found off Harihareshwar coast in Shrivardhan taluka of Raigad district on August 18. Raigad Police have ruled out any terror angle.

EC ends Soren case hearing; may send opinion to J'khand Guv soon

NEW DELHI: The hearing in the Hemant Soren mine leasing case, in which the BJP has accused him of extending himself a mining lease and sought his disqualification as an MLA, has concluded, sources said on Monday. The EC is likely to send its opinion to the Jharkhand governor in the next fortnight, they said. The Jharkhand chief minister's team has asserted before the poll panel that the provisions in the election law, which he has been accused of violating, do not apply in the case.

SP delegation meets UP DGP, alleges harassment of Azam

LUCKNOW: A delegation of the Samajwadi Party on Monday submitted a memorandum to the Uttar Pradesh Director General of Police, DS Chauhan, alleging harassment of party leader Azam Khan by the police. The delegation comprising MLA Manoj Pandey, Ravidas Mehrotra, Fahim Ahmed and Arman Khan met the DGP on the direction of party president Akhilesh Yadav, party spokesman Rajendra Chaudhary said, Officials at DGP headquarters confirmed the meeting.

Rajnath to leave for Tashkent on Tuesday to attend SCO meet

NEW DELHI: Defence Minister Rajnath Singh will travel to the Uzbek capital Tashkent on Tuesday to attend a defence ministerial conclave of the Shanghai Cooperation Organisation. Chinese Defence Minister Wei Fenghe and Russian Defence Minister Sergei Shoigu are also expected to attend the SCO meet apart from their counterparts from other member nations of the grouping. The SCO defence ministerial meeting is taking place around three weeks ahead of the annual summit of the influential grouping. The summit is scheduled for Sept 5 and 16 in Samarkand.

Shah slammed for calling T'gana govt as anti-farmer

HYDERABAD: TRS Working President K T Rama Rao on Monday took exception to Union Home Minister Amit Shah calling the Telangana government as "anti-farmer" and claimed the state dispensation's 'Rythu Bandhu' investment support scheme is a role model even for the Centre. Rama Rao questioned who had apologised to the farmers of the nation after facing their wrath over the now-repealed farm laws and after losing nearly 700 valuable lives.

JNU may change reference of V-C from 'Kulpati' to 'Kulguru'

NEW DELHI: The JNU may change the reference of vice-chancellor in Hindi from 'Kulpati' to 'Kulguru', JNU Vice-Chancellor Santishree Dhulipudi Pandit said on Monday. Delivering the Dr B R Ambedkar Lecture Series titled 'Dr B R Ambedkar's Thoughts on Gender Justice: Decoding the Uniform Civil Code', she said the proposal to change the term to Kulguru was intended to bring in more "gender neutrality." "It is due for discussion in the Executive Council on September 14, I will be changing Kulapati to Kulguru. When I came to university everything that was 'he', I made that 'she'. Now 'she' is used on all documents.

Oppn will resist voting rights to non-locals in J&K:Farooq

Former chief minister and NC president, Dr. Farooq Abdullah said on Monday that the decision to give voting rights to non-locals in J&K elections will be resisted by all the Opposition political parties. Addressing the media at the end of Monday's allparty meeting held at his high security Gupkar road residence in Srinagar, Abdullah said, "They are saying the new voters would be 25 lakhs. It could be 50 lakhs, 60 lakhs or even a crore. There is no clarity on this.

"Once the voting rights are given to non-locals, everything including the identity of the state would be lost. "We have, therefore, decided that the decision to give voting rights to non-locals will be op-

posed jointly by all of us. "The second thing, which is most important, is that many political parties have not been provided security here. How does the government plan to protect the non-local labourers after they become vulnerable?

JUSTICE CHANDRACHUD TO HEAD BENCH ON CENTRE VS DELHI GOVT

Justice D Y Chndrachud will head a constitution bench to hear the dispute between the Centre and Delhi government over control of services in Delhi, Chief Justice of India N V Ramana announced on Monday.

His announcement came when the matter was mentioned by a lawyer before a Bench, also comprising Justices Hima Kohli and C T Ravi Kumar. On May 6, the top court had referred to a 5-judge Bench the issue of control of services in Delhi.

In the split verdict on Februar 14, 2019, Justice Ashok Bhushan had ruled

that the Delhi government had no power over the administrative services, while Justice Arjan Kumar Sikri made a distinction that the transfer and posting of officers in top echelons of the bureacracy (joint director and above) can only by done by the Centre and the view of the Lieutenant governor would prevail in case of a different of opinion on matters relating to other bureaucrats. In the 2018 judgment, a five-judge Constitution Bench had unanimously held that the Lieutenant Governor of Delhi is bound by the aid and advice of the elected government, and both needed to work harmoniously with each other.

BJP leader Subramanian Swamy on Monday told the Supreme Court that the Centre should decide whether it wants to declare 'Ram Sethu' a national heritage monument.

Farmers throng Delhi for 'mahapanchayat'

SIDDA TO CASH IN ON EGG ATTACK

BJP CRITICISES HIM for visiting temple after eating non-veg food

BENGALURU: Congress leader and leader of the Opposition in the Assembly, Siddaramaiah, plans to 'hatch' the egg attack on him at Kodagu in his favour by giving a push to his aspiration of being anointed the CM candidate of his party for next year's assembly elections that is just eight months away.

He has planned a massive 'Kodagu Chalo' march right into the BJP bastion in the hilly district of Kodagu. A communique has been sent to all party legislators and functionaries, inviting them to the 'Kodagu Chalo' march scheduled for August 26.

But not all are "keen" to express solidarity with him, especially supporters of KPCC chief Shivakumar. Congress is deeply divided over Siddaramaiah hogging all the limelight. One MLA said the announcement caught everyone by surprise. "By the time we realised what was happening amid the chaos surrounding the incident, he had already announced the 'Kodagu Chalo' march," the MLA said.

Another MLA said Siddaramaiah was quick to capitalise on the egg attack issue to project himself as the CM candidate after his successful 75th birthday bash in Davanagere.

However, the march may further lead to a consolidation of Hindu votes and it is the BJP that would stand to gain. This is because the genesis of the attack on Siddaramaiah was because he wanted the posters of RSS idealogue Veer Savarkar to be removed for Muslim dominated areas in the state.

Meanwhile, the BJP has accused Siddaramaiah of consuming non-vegetarian food just before visiting a temple in Kodagu district. Party MLA Bopaiah alleged that Siddaramaiah visited the holy Basaveshwara temple in Kodlipet after eating non-veg food in Madikeri. "It is an act that has hurt the religious sentiments of Hindus," he said.

When reporters asked Siddaramaiah about the allegation, he shot back saying: "Who are you to ask this? I can eat meat and nobody can stop me, just as you can eat meat if you are a non-vegetarian. Is it okay to go to a temple the next day after eating meat the previous night? It is only the allegation of BJP leaders."

Telangana BJP chief trolled for 'carrying' Amit Shah's shoes

HYDERABAD: A video of Telangana BJP chief Bandi Sanjay rushing to fetch footwear of union Home Minister Amit Shah went viral on

social media on Monday. Sanjay, who is also a Member of Parliament, is seen carrying the footwear and keeping it in front of Amit Shah when the latter came out of Ujjaini Mahankali temple in Secunderabad on Sunday. Leaders of ruling TRS and Congress party branded Sanjay a 'slave' of Delhi and Gujarat leaders and called for safeguarding the self-respect of Telangana.
