- 1. Pursuant to the Tribunal Order, the Resolution for approval of the Scheme was transacted through remote e-voting and also e-voting at the Meeting, for which purpose the Company had engaged the services of National Securities Depository Limited ('NSDL').
- Members whose names were recorded in the Register of Members of the Company or in the Register of Beneficial Owners maintained by the Depositories as on the cut-off date, i.e. 07<sup>th</sup> June, 2024, were entitled to cast their votes by remote e-voting or evoting at the Meeting.
- 3. Voting through remote e-voting commenced at 9.00 a.m. on 11<sup>TH</sup> June, 2024 and ended at 5.00 p.m. on 13<sup>th</sup>June, 2024, when remote e-voting was blocked by NSDL.
- 4. Facility of e-voting was provided at the Meeting to those Members who did not cast their votes by remote e-voting prior to the Meeting.
- 5. After conclusion of voting at the Meeting, the votes cast through remote e-voting and e-voting at the Meeting were unblocked the same day at 11.15 A.M in the presence of 2 (two) witnesses, Ms. Shivani Mohta and Mrs. Vandana Singh neither of whom are in the employment of the Company.
