

२०१९ च्या विधानसभा निवडणुकीत राज्यात ३२ टक्के उमेदवार कोट्यधीश होते. हे प्रमाण आता ३८ टक्के (८२९ उमेदवार ) झाले आहे. विशेष म्हणजे राज्यातील सर्वांत श्रीमंत उमेदवारांच्या यादीत पहिले तीनही उमेदवार भाजपाचे असून घाटकोपर पूर्वमधील पराग शहा यांनी यावेळीही ३ हजार३८३ कोटींच्या मालमत्तेसह अव्वल स्थान कायम राखले आहे. त्यांच्या खालोखाल प्रशांत ठाकर (४७५कोटी) आणि मंगलप्रभात लोढा (४४७ कोटी) हे उमेदवा आहेत. सर्वांत गरीब उमेदवार बडनेरा मतदारसंघातील अजय मंडपे, विजय श्रीनिवास आणि बीड मतदारसंघातील अल्ताप सय्यद असून या तिन्ही अपक्षांर्च मालमत्ता प्रत्येकी फक्त दोन हजार रुपये आहे. २६ उमेदवारांनी आपल्याकडे एक रुपयांचीही मालमत्ता नसल्याचे नमूद केले आहे. २२ टक्के उमेदवारांकडे पाच कोटींपेक्षा जास्त मालमत्ता असून २० टक्के उमेदवारांकडे ५० लाखांपेक्षा कमी तर ३२ टक्के उमेदवारांकडे १० लाखापेक्षा कमी मालमत्ता आहे.
