**Sub: Disclosure under Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('Listing Regulations')**

In furtherance to our earlier letter dated December 26, 2024 and pursuant to Regulation 30 of the Listing Regulations read with SEBI Circular SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023, we wish to inform you that in the petition filed by the subsidiary of the Company, namely, Reliance NU BESS Limited (Petitioner), the Hon'ble High Court of Delhi in its hearing held on December 30, 2024, has granted extension of liberty and protection granted vide Order dated December 24, 2024 that the affiliates / subsidiaries of Petitioner shall not be disqualified from participating in additional four tenders (as per the details in attached order as Annexure A) solely on the ground of the debarment order dated November 06, 2024, issued by Solar Energy Corporation of India Limited, against the Petitioner.

**CORAM:****HON'BLE MS. JUSTICE MANMEET PRITAM SINGH ARORA****ORDER**% **30.12.2024****CM APPL. 76663/2024** (on behalf of the Petitioner under Article 226 of the Constitution of India read with Section 151 CPC seeking extension of protection granted to the Petitioner vide order dated 24.12.2024)

1. This is an application filed by the Petitioner seeking extension of the liberty and protection granted vide order dated 24.12.2024 with respect to the five (5) upcoming tenders enlisted at paragraph no. 7 of the application which are reproduced below :-

2. Learned senior counsel for the Respondent, who appears upon advance notice, states that the Petitioner cannot render the impugned order dated 06.11.2024 and Petitioner's undertaking dated 16.12.2024 ineffective by filing these applications. He further states that the Respondent specifically opposes the inclusion of the tender listed at serial no. 4 under paragraph no. 7 of the application.

3. In response, learned senior counsel for the Petitioner, on instructions, states that there are no further tenders on or before 16.01.2025 in which the Petitioner's affiliates are contemplating participating in, and therefore, no further applications are intended to be filed before 16.01.2025.

3.1 He states that the issue concerning the tender of Solar Energy Corporation of India Limited, i.e., the tender listed at serial no. 4 under paragraph no. 7 of the application, may be deferred until 16.01.2025, and the matter be placed in the supplementary list to enable the Petitioner to present its submissions regarding this tender on the said date of hearing.

4. Keeping in view the order dated 24.12.2024, the Petitioner's affiliates are hereby granted liberty to participate in the tender and bids which are enlisted at sl. nos. 1, 2, 3 and 5 of paragraph no. 7 of the application. The

issue pertaining to the entitlement of the Petitioner's affiliates to participate in the bid at sl. no. 4 will be considered by the Roster Bench on 16.01.2025.

5. Issue notice. Learned counsel for the Respondent accepts notice. Reply, if any, be filed before the next date of hearing.

6. All other terms and conditions of the order dated 24.12.2024 shall apply. It is clarified that this order has been passed without prejudice to the rights and contentions of the Respondent.

7. Keeping in view the objection of the Respondent, it is directed that no further application on behalf of the Petitioner for similar relief shall be entertained before 16.01.2025.

8. List on **16.01.2025** in the Supplementary List before Roster Bench.

9.
