We've to accept that Gandhi and, through him, India should have received the attention in the world. Gandhi is a solution to many of the global issues today."

Commenting the PM, Congress's Jairam Ramesh said, "If there is someone who has destroyed the heritage of the Mahatma, it is the 'caretaker PM'. It is his govt that has destroyed Gandhian institutions in Varanasi, Delhi and Ahmedabad. The 2024 elections are between a Mahatma follower and a Godse follower. The defeat of the 'caretaker PM' and his Godse-follower companions is evident."

In a post on X, Kharge added, "No lies are going to pack up and leave." Rahul Gandhi too took a dig at Modi and said, "Only the student of 'entire political science' would need to watch a film to know about Mahatma Gandhi."

In an interview to ABP News, Modi accused past govts

of failing to conserve heritage because they viewed things from a "slave mentality" and also there were "compulsions of appeasement." Modi cited the examples of Statue of Unity, Damul and development of Panchterth, five places associated with Babasaheb Ambedkar, all developed under his govt and said, "We have to live and connect with our history. There is cultural heritage as well. Moreover, we have to brand our 500 years of struggle (of Ram Mandir) globally. When the court gave its judgment, there was absolute peace in the country. The credit of this peace goes to all. Should we not market it?"

Asking whether India should have not marketed and branded its legacy, he accused the opposition of being concerned with "vote bank politics." Modi said the opposition's pursuit of political shortcuts restricted them to the "politics of vote bank." "That's why they turned communal, casteist and dynastic," he added.

3,000-page addl chargesheet filed in Shraddha case

New Delhi: Delhi Police has filed a 3,000-page supplementary chargesheet in the Shraddha Walker murder case. It contains various "digital evidence", including the Google location history of Aaftab Poonawala, which has been corroborated with his travel to the locations where he disposed of her body parts. Source said it also included Google locations of Shraddha's phone and showed how the phone travelled twice to Mumbai and the history disappeared when Aaftab was called for questioning.

The chargesheet also contains the search history of Aaftab with references to the use of "Bansun", etc. His other search history also corresponds to the events that unfolded, the cops have claimed. A senior police officer said the supplementary chargesheet had been filed in the court of Aviral Shukla, metropolitan magistrate in Saket Court, with respect to the digital investigation conducted in the

case. Aaftab, then 28, and 27-year-old Shraddha were from Visali near Mumbai and shifted to Delhi in May 2022. He allegedly killed Shraddha on May 18, 2022. Police had filed the first chargesheet in the case in Feb last year in which they stated that after killing Shraddha, Aaftab had gone to a nearby shop and bought a saw, three blades, a hammer and plastic clips. He returned home and moved the body to the bathroom and severed her hand at the wrists with the saw and put them in a white polybag.

Mamata: TMC to move EC if PM's meditation part televised

Baruipur: West Bengal chief minister Mamata Banerjee on Wednesday said the Trinamool Congress will complain to the Election Commission if Prime Minister Narendra Modi's meditation in Kanyakumari is televised, claiming that it would be a violation of the election Model Code of Conduct (MCC).

Modi is scheduled to meditate at Rock Memorial, a monument built in tribute to Swami Vivekananda, in Kanyakumari following the culmination of the Lok Sabha polls campaign on May 30, according to BJP leaders.



"We will complain, but we cannot be aired on television," she said, claiming that this will amount to "violation of MCC." "Does anyone have to get cameras for doing meditation?" she asked, claiming that it was a way of canvassing.

Cong cites poll code, asks EC to bar 'maun vrat' media coverage

New Delhi: Congress has urged Election Commission to ensure that PM Narendra Modi does not use his "maun vrat" (silence vow/meditation) for campaign purposes to "circumvent" the "silent period" just ahead of the last phase of polling on June 1.

Modi plans to start his maun vrat from Vivekananda Memorial in Kanyakumari on Thursday, Congress has claimed, in its memorandum to EC, that "through the meditation trip, Modi is attempting to

circumvent 48-hour silence period and unfairly leverage the ethno-cultural significance of the chosen location in an attempt to bolster his campaign and maximise his vote share; in violation of Representation of the People Act, as well as Model Code of Conduct (MCC). "The party has asked EC to ensure the PM's meditation is not broadcast, telecast or printed during the silent period of the campaign, as that would be a complete violation of MCC." "The PM can start his meditation after 24-48 hours, which is from the evening of June 1," Congress's Abhishek Manu Singhvi told reporters.

2k cops posted for PM's Kanyakumari event

Kanyakumari: All arrangements, including heavy security, are in place for Prime Minister Narendra Modi's 45-hour stay at the famed, mid-sea Vivekananda Rock Memorial here on Thursday as he would start his maun vrat from the place named after the revered Hindu saint.

DMK in Tamil Nadu petitioned the district collector

against granting permission for the PM's spiritual sojourn, citing the election model code of conduct that is in force, besides the ongoing tourism season, that would see a good influx of domestic and foreign tourists. The beach will be out of bounds for tourists from Thursday to Saturday and private boats would also not be allowed to ferry.

The district in the country's southern most tip will see a strong posse of 2,000 police personnel and various security agencies maintain a tight vigil during the PM's event, they said after he went on a similar meditation exercise in a Kodanath cave after the 2019 poll campaign.

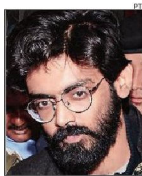
Sharjeel gets bail in sedition case but won't walk out of jail

Still No Relief In '20 Riots Larger Conspiracy Case'

New Delhi: Delhi high court on Wednesday granted statutory bail to Sharjeel Nohri, a scholar at Jawaharlian Nehru University (JNU) who was charged with sedition and illegal activities. He will, however, remain in jail as he has not been granted relief in the larger conspiracy case related to the riots.

In Feb this year, a trial court had denied Imambail

led the order and sought bail on the ground that he had undergone half of the maximum sentence of seven years that could be awarded to him, if convicted.

A division bench of Justices Suresh Kumar Kait and Manoj Jain allowed the appeal after hearing arguments from Imambail's counsel and Delhi Police. The prosecution opposed the plea on the ground that Imambail had not undergone half the sentence and said the delayed period of pre-trial detention was solely attributable to Imambail, on whose instance the trial was stayed in 2022.

The counsel for Imambail submitted he had already undergone four years and seven months of incarceration out of the seven years of maximum imprisonment.

Earlier this year, the trial court had said that "although Imambail did not ask anybody to pick up weapons and kill people, his speeches and activities had mobilised the public, which disrupted the city", and might have been the main reason for the outbreak of the riots.

"Through inflammatory speeches and social media, the applicant skillfully manipulated the real facts and incited the public in order to create havoc," additional sessions Judge Sameer Bajpai had said in the order.

Imambail was arrested in January 2020 after a sedition case was registered against him.

HC relief to Azam, family in fake cert case

Baruilly: Tazeen Fatima (75), wife of Samajwadi Party's Azam Khan, was released from Rampur district jail on Wednesday after the Allahabad High Court granted bail to her and their son Abdullah Azam Khan in the fake birth certificate case last week. The three family members were convicted of forgery by a Rampur court.

Azam and Abdullah remain behind bars as several other cases are pending against them. Fatima was in jail since Oct 28, last year after being convicted by the local court.

Fatima said, "We were convicted due to a well-planned conspiracy involving the police, govt, and even the media. We provided pieces of evidence to support our innocence. As a former govt servant, I had taken maternity leave. Forensic and video evidence shows Abdullah in my lap in 1999, but the court did not take cognisance of it."

Reinstated doc on MIA, min's letter, says dean, sent on leave

Pune: Revelations about Sassoon General Hospital's arrested forensic sciences head Dr Ajay Taware being reinstated as medical superintendent in April based on a recommendation by medical education minister Hasan Musrif and NCP MLA Sunil Thengre led to a set-up to examine the role of the doctor in the case. Taware, who is in custody along with casually medical officer Dr Shirish Halnur, a mortuary staffer Atul Ghatkamble for allegedly manipulating an alcohol test in the accident case involving a Pune builder's 17-year-old son, had been stripped of the post of medical superintendent over his suspected involvement in a kidney racket at the state-run hospital. The action against Kalle came after the state govt issued an order to the Directorate of Medical Education and Research to set up a committee to probe malpractice linked to the Porsche case.

"It has also come to notice that Dr Kalle did not understand the seriousness of the incident and could not handle the situation well. In view of this, the committee recom-

mends that Dr Kalle be sent on forced leave," states the order. In a separate order, the state govt suspended Taware and Halnur under the Maharashtra Civil Services (Conduct) Rules 1979. Till their suspension is in force, they are barred from medical practice and investing in any business. Ghatkamble, a Class IV employee, was also suspended on grounds of violating service rules.

The other children managed to rush outside, but Srihiti's foot got stuck in a bicycle's wheel near the door as she was leaving.

Despite villagers' efforts to save her, Srihiti could not be rescued. The fire engulfed the entire house, along with two goats and other belongings.

Mahantim SHO Omprakash said: "The cause of the fire is yet to be ascertained, but initial investigations suggest that it may have been caused by a kerosene lamp used for lighting. The family has received immediate financial assistance of Rs3 lakh under Kar-ri Anteyashanti Yojana and the 20,000 under the family benefit scheme. The body was handed over to them after autopsy."

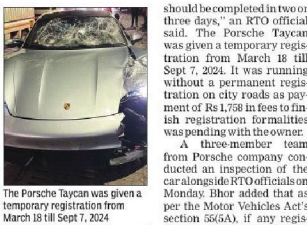
RTO cancels killer Porsche's temporary registration cert

Pune: Pune Regional Transport Office (RTO) has cancelled the temporary registration certificate of the Porsche Taycan involved in the May 19 accident that resulted in the death of two technicians in Kalyanagar.

All relevant formalities have been completed and details of the vehicle sent to Bengaluru Central RTO on Wednesday. Pune regional transport officer Sanjiv Bhor said, adding: "The original temporary registration was issued by Bengaluru Central RTO. Hence, they have been informed. Now, they will complete the rest of the formalities from now on. After the car can be registered again, provided it is fit for the road. The de-registration process should be completed in two or three days," an RTO official said. The Porsche Taycan was given a temporary registration from March 16 till Sept 7, 2024. It was running without a permanent registration on city roads as payment of Rs 1,750 in fees to finish the registration formalities was pending with the owner.

A three-member team from Porsche company conducted an inspection of the car alongside RTO officials on Monday. Bhor added that as per the Motor Vehicles Act's section 56(5A), if any registered or other prescribed authority has reason to believe that a motor vehicle within its jurisdiction has been used in the commission of an offence punishable under the Act's section 199A, the authority may cancel the certificate.
