Success lies in how I prepare my team for the future: Modi

New Delhi, 10 January

In his podcast debut, released on Friday, Prime Minister Narendra Modi said he considers the benchmark of his success would be to shape an able team that will deftly handle things in the years to come, and spoke of his enormous faith in the country's youth.

In an over two-hour long podcast, hosted by Zerodha co-founder Nikhil Kamath, the PM spoke on an array of issues, such as his personal and leadership goals, including those for his third term in office. When Kamath asked him if he has planned for the time beyond him, training those he has faith in, not for today but after 20-30 years, Modi said, "When I was in Gujarat, I would say that I want to go after preparing (team) for the next 20 years. I am doing it. My success lies in how I prepare my team who will be able to deftly handle things. This is my benchmark for me."

The PM identified the US refusing him a visa in 2005, when he was the Gujarat chief minister, as a "setback" not for him personally, since he had visited the US previously and had as such no desire to visit it, but an "insult" to a democratically elected government, a state, and a nation. He said at a press conference that day he said that there will soon be a time when the world would queue up to get an Indian visa. "India's time has arrived. I can see that happening," the PM said.

Modi stressed his ideologi-

cal moorings of "nation first", which allows him to discard obsolete ideas and embrace new ones as long as they are in the nation's interest. He attributed to his good fortune that he has to live out of his comfort zone, and has enormous risk-taking capacity, which he believed has not been fully utilised yet. "I have an enormous risk-taking capacity because I do not care about myself," he said.

To Kamath's question how he dealt with anxiety, the PM said that in his position, earlier as the CM of Gujarat and now as the PM, he has tried to detach himself from emotions, and rise above the natural tendencies of human beings at such junctures. In this context, he spoke of the counting day of the December 2002 Gujarat Assembly polls, which he said was the biggest test of his life. Modi had become the state's CM the previous year. He also spoke of the February 2002

Godhra train burning day and the serial bomb blasts that hit Ahmedabad in July 2008 as some other such moments.

Modi said it has been his life's mantra that he may make mistakes but will not do anything wrong out of bad intentions. "When I became the CM, I said I will not spare any effort to work hard. I will not do anything for myself. And, thirdly, I am human and I can make mistakes. But I will not do anything wrong out of bad intentions. I have made it a mantra of my life. Mistakes are inevitable. I must have made mistakes. I am a human too, not a god," he said.

The PM said his vision was to ensure 100 per cent delivery of services to beneficiaries without any discrimination, which was "true social justice and true secularism". Modi described himself as not a typical politician, and his time is mostly spent on governance. "I have to make political speeches

during elections. It is my compulsion. I don't like it but I have to do it," he said.

Modi said his thrust on "minimum government, maximum governance" was misinterpreted by some people who thought it meant fewer ministers or government employees. In the last 10 years, his government has repealed over 1,500 archaic laws and junked 40,000 compliances, he said.

About his personal life, the PM said he was an average student in school and expressed his disappointment at his father refusing to send him to a Sainik school for lack of money. He said he was not a foodie.

Recognised for his oratory, Modi stressed that communication is more important than oratorical skills and pointed to the example of Mahatma Gandhi, saying that he lived such a life which did the "talking" for him and rallied the nation behind him during the freedom movement.

MP, KARNATAKA, MAHA AMONG STATES SEEING HIGHER WOMEN VOTER TURNOUT

WOMEN-CENTRIC SCHEMES HELP BOOST THEIR TURNOUT IN POLLS

Andhra Pradesh, Assam, Chhattisgarh, Karnataka, Madhya Pradesh, Maharashtra and Odisha are among the states that saw an increase in women turnout ratio in 2024 mainly due to women-centric schemes.

Meanwhile, Uttar Pradesh, Punjab, Rajasthan, West Bengal, Gujarat and Haryana have seen a decline in turnout ratio of women. SBI Research's recent analysis, based on the Election Commission's electoral data, has found that states that have rolled out one or more women-centric schemes have witnessed an incremental women voter turnout of 18 million in 2024 over 2019.

The analysis, released on Thursday, attributed the rise to the implementation of schemes like Mudra Yojana and Pradhan Mantri Awas Yojana (PMAY). It said improved electricity supply and access to potable water also contributed to the trend.

The analysis mapped the PM Jan Dhan Yojana (PMJDY) and Mudra scheme accounts to claim that "women electoral participation is increasing with rising numbers of women PMJDY and women Mudra loan accounts".

Govt working on no interest warehousing for farmers, says Chouhan

New Delhi, 10 January

Ahead of the Union Budget, Union Agriculture Minister Shri Singh Chouhan on Friday said the government was trying to ensure that farmers do not have to pay any interest to keep produce in a warehouse for two to three months.

Chouhan said the agriculture ministry approached Union Finance Minister Nirmala Sitharaman to allow farmers to get paid on the basis of warehouse receipts. The government was also trying to lower the price gap between what consumers pay and what producers get, he said.

The Centre recently launched a Credit Guarantee Scheme for Electronic-Negotiable Warehouse Receipt (e-NWR) based Pledge Financing (CGS-NPF) which provides a corpus of ₹1,000 crore for post-harvest finance. This can be availed by farmers against electronic negotiable warehouse receipts after depositing commodities in Warehousing Development and Regulatory Authority (WDRA) accredited warehouses.

State plans ecomm boost for MSME sector

Lucknow, 10 January

To propel the growth of micro, small and medium enterprises (MSMEs), and enhance their competitiveness, the Uttar Pradesh (UP) government is planning to interconnect 155 industrial clusters with a dedicated e-commerce (e-comm) platform.

This move is expected to benefit over 50,000 industrial and manufacturing units of these clusters, administered by the UP State Industrial Development Authority (UPSIDA). The dedicated portal is being developed by the UPSIDA, and will connect raw material suppliers, manufacturers, and finished goods vendors operating out of

these 155 clusters. Reducing reliance on external suppliers and cutting costs, the proposed e-marketplace can facilitate direct business-to-business transactions, fostering trade and alliances. "The e-market is a step towards realising the 'Make in UP' vision. By fostering a robust industrial ecosystem, we aim to make UP a global manufacturing hub," UPSIDA Chief Executive Officer (CEO) Mayur Maheshwari said.

He noted that the e-marketplace, which is under the testing phase before launch, would help UP-based industries to save about ₹20,000 crore in logistics and warehousing costs.

The project is also aimed at contributing to the flagship trillion-dollar economy

agenda of the Yogi Adityanath-led UP government.

The UPSIDA's digital platform will enhance trade among the state industries, which is expected to catalyse the industrial growth, generate fresh jobs, and increase goods and services tax (GST) kitty by 7-10 per cent. Also, by promoting local sourcing and reducing logistics costs, the e-market will strengthen UP's economy, streamline procurement processes, and improve transparency. The e-market will also take on board units engaged in packaging and marketing activities to offer a complete industrial value chain of services to clients.

At the same time, the state government is increasing the industrial land bank, with a target to amass over 150,000 acres for industrial and infrastructure development.
