

HC transfers ex-Shiv Sena (UBT) corporator Ghosalkar murder case to CBI

Mumbai, Sept 6 (UND) : In a major development, the Bombay High Court on Friday transferred the investigation of former Shiv Sena (UBT) corporator Abhishek Ghosalkar to the Central Bureau of Investigation (CBI). The court today allowed a plea by Tejavee Ghosalkar, widow of Abhishek Ghosalkar while directing the Mumbai Police to hand over the investigation papers to CBI at the earliest within two weeks and further directed the zonal director of CBI to appoint an IPS-grade officer below the rank of superintendent of police to investigate the case. It also said that the CBI is at liberty to appoint the team of officers. While handing over investigation to the central agency, the court observed that all "angles in the case are not probed" and "such lapses cannot be allowed to continue as it will result in miscarriage of justice".

SDPI hold protest against hateful politics, mob violence against Muslims

Chhatrapati Sambhajinagar, Sep 6 (UND) Social Democratic Party of India (SDPI) on Friday held a statewide protest against growing politics of hatred and incidents of mob violence against Muslims in Maharashtra. A strong protest was held here in front of the district collector's office here. The main objective of the agitation was to protest the violence against Muslims in Maharashtra, especially lynching and the communal hatred being spread by some politicians.

The SDPI leaders strongly condemned the statements of BJP MLA Nitesh Rane and Ramgiri Maharaj, who were accused of spreading hatred and incidents of mob violence against Muslims in Maharashtra. Speaking on this occasion, Maharashtra SDPI president Syed Kalim said, "Rising communalism and mob violence in Maharashtra is a threat to peace and unity in the state. People like Rane, Ramgiri Maharaj are fueling this hatred. We demand the state government to stop these incidents immediately and take strict action against the culprits."
