2) The above un-audited consolidated financial results of Barbeque-Nation Hospitality Limited (the "Holding Company") and its subsidiaries (together referred to as the 'Group') have been reviewed by the Audit Committee and approved by the Board of Directors at their respective meeting held on February 3, 2025. The statutory auditors of the Holding Company have carried out the limited review of the unaudited consolidated financial results for the quarter and nine months' ended December 31, 2024.

3) The un-audited consolidated financial results for the said period have been prepared in accordance with the recognition and measurement principles laid down in the applicable Indian Accounting Standards ("Ind AS") as prescribed under Section 133 of the Companies Act, 2013, as amended, read with relevant rules made thereunder and in terms of Regulation 33 of the SEBI Listing Regulations, as amended from time to time.

4) The Group is solely engaged in the business of restaurant services. The economic characteristics, nature of service provided, production and distribution process of the Group are similar. Hence, the management has determined that the group operates as a single segment.

5) The Board of Directors of the Holding Company at its meeting held on May 27. 2023 had approved the removal (strikeoff) of Barbeque Nation Holdings Pvt Ltd ("Barbeque Mauritius"), a wholly owned subsidiary of the Holding Company, Incorporated in Mauritius, from the Register of Companies, subject to approval of Regulatory Authorities in Mauritius, The application filed by Barbeque Mauritius has been approved by the Registrar of Companies in Mauritius ("RoC, Mauritius") and pursuant to the letter Issued by RoC, Mauritius, Barbeque Mauritius has been removed (struck-off) from the Register under Section 308 of the Mauritius Companies Act, 2001 with effect from December 02, 2024.

6) Previous periods figures have been regrouped/reclassified, wherever necessary.
