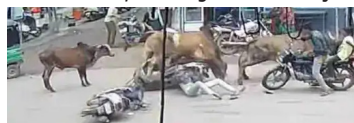

Bike rider jumps and falls 10 feet away Triple rider bike runs over cattle sitting in middle of road, shocking incident of Rajula



Amreli. The cruelty of stray cattle is increasing day by day across the state. Many people have to lose their lives due to the torturing of stray cattle. A shocking CCTV footage from Amreli's Rajula has come to the fore, in which the three young bikers jumped and fell 10 feet away after the triple rider bike rode on the cattle sitting in the middle of the road.

The CCTV footage in the August 4 accident in Rajula has also come to the fore, in which the triple rider bike is seen to have run over the cattle. According to the CCTV information, on Jafarabad Road of Rajula city, late at night on the 4th, stray cattle were sitting on the public road. Then the speeding triple rider got on the bike without the animals seeing it. In which the three bikers jumped off the bike and fell about 10 feet, due to which the three youths got serious injuries and the locals shifted them to the hospital.

The CCTV footage of the incident on August 4 has surfaced. A two-wheeler driver was run over by bulls roaming the roads in Amreli's Dhari near the main gate of Dhari, while another motorcyclist narrowly escaped with his life. So other motorists and pedestrians passing on the road also had a stampede due to the bull fight.

A doctor named Tushar Patel was injured when he was mauled by bulls near the main gate of Dhari. He was working in a hospital named Vatsalya in Dhari. Tushar Patel was passing through the main gate with his two-wheeler when two bulls running on the road rammed his two-wheeler, knocking him into the ground.

Vehicles get stuck on the roads of Dharampur Bediawadi every day

Khambhalaya, A short road without a railway gate to Zilla Seva Sadan in Khambhalaya, the headquarters of Devbhoomi district, is in Bedyawadi Khawas Wadi in Dharampur. It has been approved to build a new road at a cost of 1.14 crores and after the contract was awarded in March 2024, there are complaints that the contractor is digging the road and working without level in the provincial office, Mamlatdar office, done Meanwhile, amidst the complaints of work being done without a center line, vehicles such as tractors and rickshaws leaving here get stuck every day when the road is dug and filled with water during the monsoon, so that the road is in a state of closure. Scenes where vehicles have to be towed with ropes getting stuck everyday, have become common now, if it is very thick mud, how to go for two wheelers or even on foot is a serious question. People are not interested in solving this problem and there is resentment.
