Sub.: Passing of Resolutions through Postal Ballot (Remote E-voting only)

I was appointed as the Scrutinizer by IndiGrid Investment Managers Limited (Investment Manager) the Investment Manager of "India Grid Trust" (hereinafter referred to as the IndiGrid) in their meeting held on 25th October 2024, to scrutinize the Postal Ballot Remote E-voting process pursuant to applicable provisions of Securities and Exchanges Board of India (Infrastructure Investment Trusts) Regulations, 2014 as amended and the notifications, circulars and guidelines issued thereunder (including any statutory modification(s) or amendment(s) or re-enactment(s) thereof for the time being in force ("InvIT Regulations") and subject to other applicable laws and regulations This was carried out in respect of the Resolutions as circulated/ stated in the Postal Ballot Notice ('Notice') dated October 29, 2024. The Notice sent sought the approval of the Unit Holders through remote e-voting only.

Report on Scrutiny:

- Investment Manager had appointed National Securities Depository Limited (NSDL) as
 the service provider, for the purpose of extending the facility of Remote E-voting to
 the Unit Holders of "IndiGrid". KFin Technologies Limited (formerly KFin Technologies
 Private Ltd.) is the Registrars and Transfer Agents 'RTA' for the Unit holders of the
 IndiGrid.
- The Service Provider had provided a system for recording the votes of the Unit holders electronically through Remote E-voting on the items of business sought to be transacted through Postal Ballot. NSDL had generated E-Voting Event Number (EVEN):
 132021 for the votes to be cast through e-voting mode.
- The Service Provider had set up electronic voting facility on their website, <u>https://evoting.nsdl.com</u>. The Investment Manager had also uploaded the items of the business to be transacted through postal ballot on the website of the IndiGrid and also that of the Service Provider to facilitate their Unit holders to cast their vote through Remote E-voting.

- Necessary instructions in relation to voting by postal ballot were duly mentioned in the Notice dated October 29, 2024 sent to the unit holders of IndiGrid electronically. As per the regulatory permissions in place, the Notice was sent by email only to the extent emails were made available as part of the beneficiary download provided by the two Depositories. The above activities were completed by October 29, 2024. The Register of unit holders was made up, for the purpose of sending the Notice by email as of Friday, October 25, 2024 (cut-off date).
- As on cut-off date, there were 35,454 Unit holders holding 83,45,58,088 Units of the IndiGrid. The service provider had sent the postal ballot notices electronically which also specified the manner in which e-voting needs to be done.
- The Cut-off date for the purpose of identifying the Unit holders who will be entitled to vote on the resolutions placed for approval of the Unit holders was Friday, October 25, 2024.
- The Remote E-voting facility was kept open for twenty one days from Thursday October 30, 2024 at 09:00 A.M. to Tuesday November 19, 2024 till 5.00 P.M.
- The IndiGrid completed the dispatch of the notices through electronic mode to the Unit holders.
- At the end of the remote e-voting period on Tuesday November 19, 2024 at 5.00 P.M., the voting portal of the Service Provider was blocked forthwith.

For wider circulation of the notice, an advertisement was published by the IndiGrid in "Financial Express" English Newspaper, and in "Loksatta" Marathi Newspaper, both dated October 30, 2024 informing about the completion of dispatch of the Notices and e-voting process.

On Tuesday October 19, 2024, after the closure of e-voting process at 5.00 P.M., the votes cast through e-voting facility were duly unblocked by me as a Scrutinizer in the presence of Mr. Kartik Madrecha and Mrs. Amita Jadav who acted as witnesses (not in employment with

the IndiGrid or Investment Manager). Since, e-voting facility was provided by NSDL, the details of the e-voting exercised by the unit holders were taken as final.

On scrutiny, I report that out of 35,454 unitholders holding units as on the cut-off date, October 25, 2024, 292 Unit holders have exercised their votes through e-voting. The details of Postal Ballot results for the items placed for consideration and approval of the unit holders are given below:

RESULTS:-

292 Unit holders holding 29,85,32,672 Units participated in the remote e-voting. Out of which, 282 Unit holders holding 29,85,16,785 Units voted in favour constituting 99.995% and 10 Unit holders holding 15,887 Units voted against the resolution constituting 0.005%.

As the number of votes cast in favour of the Resolution is more than 60% of the total votes cast, I report that the Resolution as set forth in Item No. 1 of Notice dated October 29, 2024 has been passed by the Unitholders with requisite majority.
