Interim Financial Reporting prescribed under Section 133 of the Companies Act, 2013 (the 'Act') read with relevant rules issued thereunder and other accounting principles generally accepted in India and in compliance with Regulation 33 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended from time to time (the 'Listing Regulations'). Any application guidance/ clarifications/ directions issued by Reserve Bank of India ('RBI') or other regulators are implemented as and when they are issued/ applicable.
- The above results have been reviewed by the Audit Committee and subsequently approved by the Board of Directors at their respective meetings held on August 09, 2024 subjected to the limited review by the Statutory Auditors of the Company pursuant to Regulation 33 of Listing Regulations as amended.
- The Board of Directors of the Company at its meeting held on May 10, 2024 approved the issue of equity shares of the Company on rights issue basis for an amount not exceending Rs. 15,00,00,000/- (Rupees Fifteen Crore Only) to the eligible existing shareholders of the Company.
- 4 The EPS has been computed in accordance with the Indian Accounting Standard.
- The Company's main business is dealing in shares, securities, Futures and Options. All other activities of the Company revolve around its main business. As such, there are no separate reportable operating segments as per IND AS 108- Operating Segments.
- The Company is involved in the business of investing in Shares, Futures and Options for its own account and as such has no customer base/interface at all; therefore there is no impact of Master Direction-Reserve Bank of India (Transfer of Loan Exposures) Directions, 2021 issued by the Reserve Bank of India vide their notification no. RBI Notification No. RBI/DOR/2021-22/86. DOR.STR.REC.51/21.04.048/2021-22 dated September 24, 2021.
- 7 Considering the nature of business, provision for income tax has not been made. Accordingly, Advance-tax has not been paid during the quarter ending June 30, 2024.
