**Sub: Rumour Verification: Regulation 30(11) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015**

**Ref.: Clarification / Confirmation on news item sought by BSE Limited and National Stock Exchange of India Limited (together, the "Stock Exchanges") each dated February 11, 2025 in respect to certain media report published on February 11, 2025 and increase in the price of the Company's shares on February 11, 2025.**

A material price movement was observed in Company's stock price yesterday.

While the Company was in the process of making relevant clarification under Regulation 30(11) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (SEBI LODR Regulations), it received a communication from Stock Exchanges seeking clarification with respect to (i) media report which appeared in the [www.economictimes.indiatimes.com](http://www.economictimes.indiatimes.com) on February 11, 2025, captioned "*Adani Enterprises shares rally 4% on \$686 million investment in not-for-profit healthcare initiative*" ("**Media Report**") and (ii) increase in the price of the securities of the Company listed on the Stock Exchanges on February 11, 2025.

In this regard, we wish to clarify that the aforementioned media report relates to the proposed Adani Health City (AHC) integrated health campuses, to be implemented through the Group's not-for-profit healthcare entities. This initiative is not being undertaken by the Company hence the Company is unable to comment on this.

The increase or movement in the price of the scrip of any company are purely due to market conditions and absolutely market driven. The management of the Company neither has any control nor has any knowledge of the reasons for the increase in the price of its equity shares.
