## Conmen steal Rs 1.63L from credit, debit card of retired officer

Conmen managed to steal Rs 1.63 lakh from the bank account of a retired officer from a government department in Aerodrome area, police said on Tuesday. The complainant had searched for the customer care number of an ewallet company when a caller posed himself as the officer of the e-wallet company and managed to steal money from his credit and debit card. When he came to know about the fraud, he informed bank officers and later lodged a complaint with the police.

He had seen some numbers on the internet and called on one such number on August 5. The receiver, who was a conman, informed him that he is the customer care officer of the e-wallet company. Shrimal told him about his e-wallet when the accused downloaded two remotely accessed applications to the mobile phone of

complainant. After that, conmen got access to the mobile phone of the complainant and managed to steal Rs 93600 from his credit card and Rs 76k from his debit card. A total of

कीव-मास्को। युक्रेन ने रूस के 1,000 वर्ग किमी से ज्यादा इलाके पर कब्जा कर लिया है। उठठ के मताबिक एक सप्ताह पहले युक्रेनी सैनिकों ने रूस के कुर्स्क इलाके पर हमला किया था। तब से यहां के करीब 28 गांवों पर कब्जा कर चुके हैं।

कुर्स्क में टैंकों और तोपखानों से लैस करीब एक हजार यूक्रेनी सैनिक 6 अगस्त को दाखिल हुए थे। इसके बाद रूस ने 8 अगस्त को ही यहां इमरजेंसी लगा दी थी। रूसी





राष्ट्रपति व्लादिमीर पुतिन ने इसे यूक्रेन की उकसाने वाली हरकत बताया है। उन्होंने अपने रक्षा अधिकारियों को युक्रेनी सेना को रूसी इलाके से खदेड़ने का आदेश दिया है।

पुतिन बोले- युक्रेन के साथ कोई समझौता नहीं करेंगे-पुतिन ने कहा कि युक्रेन, रूसी इलाके पर कब्जा कर सीजफायर समझौते के लिए अपना पक्ष मजबूत करना चाहता है, लेकिन हम उन लोगों के साथ कोई समझौता नहीं करने वाले हैं। पुतिन ने युक्रेन पर रूसी नागरिकों की हत्या करने और न्यूक्लियर पावर प्लांट के नजदीक हमला करने का आरोप लगाया।यूक्रेन के राष्ट्रपति जेलेंस्की ने बीते रविवार को माना था कि
