On the said date, two new applications being C.A. No. 16 and 17 of 2024 filed by the Petitioners (Mr. Mahendra Mohan Gupta, Mr. Shailesh Gupta, VRSM Enterprises LLP) with respect to the affairs of Jagran Media Network Investment Private Limited were taken up. The Hon'ble NCLT after hearing the parties issued notice, and directed that replies, if any, be filed within a period of one week.

Thereafter, the senior counsel for the Petitioners continued with his submissions as a part of the ongoing final arguments in the matter, and such arguments continued till 4 P.M.

The Hon'ble NCLT was pleased to list the matter for further hearing on 9th September, 2024 at 02:30 P.M., on which date the Petitioners will continue with their arguments.
