#### Dear Sir/Madam,

This is with reference to the announcement dated July 03, 2024, regarding the submission of the certificate under provisions of SEBI (Depositories and Participants) Regulations, 2018 for the quarter ended June 30, 2024, wherein it was observed that the Company has submitted registrar and share transfer agent confirmation certificate of another company i.e. "Kohinoor Broadcasting Corporation Limited" instead of "Kohinoor Foods Limited". Further, on July 04, 2024, the Company submitted revised disclosure stating to inadvertently wrong certificate was submitted on July 03,2024.

The consequential effect on account of the inadequate disclosure resulted into violation of Regulation 4(1)(c) and 4(1)(e) of the Regulation which states that the 'the listed entity shall refrain from misrepresentation and ensure that the information provided to recognised stock exchange(s) and investors is not misleading and the listed entity shall ensure that disseminations made under provisions of these regulations and circulars made thereunder, are adequate, accurate, explicit, timely and presented in a simple language.

The above violation on your part has been viewed seriously. You are hereby warned and advised to be careful in future, exercise due caution and initiate corrective steps to avoid recurrence of such lapses so as to ensure due compliance with the applicable provisions of the Regulation. Any aberration in future will be viewed seriously and appropriate action would be initiated.
