Opinion

We have audited the accompanying Statement of Standalone Financials Results of Girnar Spintex Industries Limited ('the Company') for the quarter and year ended March 31st, 2024 ('the statement') being submitted by the company pursuant to the requirement of Regulation 33 of SEBI (Listing Obligation and Disclosure _Requirements) Regulation, 2015 read with SEBI Circular No. CIR/CFD/FAC/ 62/ 2016 dated July 5, 2016.

In our opinion and to the best of our information and according to the explanation given to us, the statement:

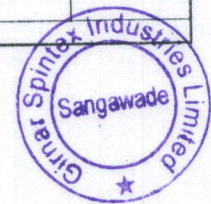


