STL Global Limited held on Mondaythe 30th day of September, 2024 at 11:00 A.M. (IST) through Video Conferencing/Other Audio-Visual Means.

I, Vijay Bahadur, a Practicing Company Secretaryhave been appointed by the Board of Directors of M/s. STL Global Limited (the Company), as a Scrutinizer for the purpose of scrutinizing remote e-voting/Poll at the Annual General Meeting (AGM) venue and ascertaining the requisite majority, on the resolutions contained in the notice to the 27thAnnual General Meeting of the members of the Company, held on Monday, September 30, 2024 at 11:00 A.M. (IST)through Video Conferencing/Other Audio-Visual Means.



The Notice dated 13thAugust, 2024 along with statements setting out material facts Under Section 102 of the Act were sent to the shareholders in respect of the below mentioned resolutions passed at the Annual General Meeting of the Company.

The Public Advertisement in respect of dispatch of notices and conducting of voting through electronic means were published in an English newspaper "Financial Express" and in a Hindinewspaper "Jansatta" having wide circulation, in their respective editions dated 29thAugust, 2024&06thSeptember, 2024 respectively.

The Management of the Company is responsible to ensure the compliance with the requirements of the Companies Act, 2013 and the rules relating to voting through electronic means on the resolutions contained in the Notice of the 27thAnnual General Meeting (AGM) of the member of the Company. My responsibility as a scrutinizer for the e-voting process is restricted to presenting a Scrutinizer's Report on the votes cast "in favour" or "against" or "abstained", in respect of the resolutions stated below, based on the reports generated from the e-voting system provided by M/s. Link Intime India Private Limited, the authorized agency to provide e-voting facilities, engaged by the Company.

Remote e-voting
