

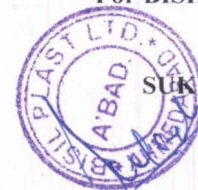

Review Report to the Board of Directors of Bisil Plast Limited
