Disclosure regarding TSI Yatra Private Limited (“**TSI**”), a material wholly owned subsidiary of the Company.

This is in furtherance to our intimation dated October 16, 2024, regarding the admission of TSI, into Corporate Insolvency Resolution Process (“**CIRP**”) under the Insolvency and Bankruptcy Code, 2016 (“**IBC**”) by an order dated October 15, 2024 (“**Impugned Order**”) passed by Hon’ble National Company Law Tribunal, New Delhi (“**NCLT**”) in a petition (“**Petition**”) filed by Ezeego Travels & Tours Ltd. (currently under liquidation).

As an update, on October 17, 2024, the erstwhile Director of TSI, filed Company Appeal bearing no. (AT)(Ins) - 1951/ND/2024 challenging the Impugned Order before the Hon’ble National Company Law Appellate Tribunal, New Delhi (“**Appellate Tribunal**”).

By an order pronounced on October 18, 2024 (“**Stay Order**”), the Hon’ble Appellate Tribunal stayed the operation of the Impugned Order. A copy of the Stay Order is yet to be received.
