**Sub: Outcome of Nomination, Remuneration and Compensation Committee Meeting.**

This is to inform you that the Nomination, Remuneration and Compensation (NRC) Committee of the Board in its meeting held on 8<sup>th</sup> August, 2024 has inter alia transacted the following business:

1. Approved grant of 25,000 Stock Options under Employees Stock Option Plan 2018 (ESOP 2018 Scheme) to the identified employee of the company on the terms and conditions as placed before the Nomination, Remuneration and Compensation Committee Meeting.
2. Approved allotment of 12,500 Equity shares of Rs.10 each under ESOP - 2007 scheme and 35,386 Equity shares of Rs.10 each under ESOP - 2018 to the eligible employees of the Company on exercise of stock options vested in them.

Consequently, on allotment of equity shares under ESOP Scheme-2007 and ESOP Scheme-2018, the issued, subscribed and the paid-up Equity Share capital of the Company has increased from 2,47,90,126 equity shares to 2,48,38,012 Equity shares of Rs.10 Each.
