ભરૂચ પાલિકાના મેદાનમાં ઘૂંટણ સમાં પાણી ભરાયાં ભરૂચ, તા.૨ હિન્દૂ સમાજના પવિત્ર શ્રાવણ માસના ભરૂચ નગરપાલિકામાં પાણી ભરાતા લોકોમાં ચર્ચા ચાલી હતી કે શહેરને છોડો ખુદ છેલ્લા દિવસે સોમવતી અમાસના રોજ નગરપાલિકા પોતાની કચેરી વિસ્તારમાં પાણીનો નિકાલ કરવામાં નિષ્ફળ છે. વરસાદની મેઘરાજાએ આકાશમાંથી વરસાદની રમઝટ બેટિંગ થતા જ રાબેટમુજબ નગરપાલિકાના કમ્પાઉન્ડમાં ફાયર વિભાગ પાસે ઘૂંટણ સમા બોલાવી દીધી હતી. ભરુચ શહેર અને પાણી ભરાઈ જાય છે ત્યારે નગરપાલિકાએ શહેરના વિસ્તારોમાં અને પાલિકા કચેરી પાસે તાલુકામાં બપોરથી જ એકધારો વરસાદ પાણીના નિકાલની સુયોગ્ય વ્યવસ્થા કરવી જોઈએ તેવી લોકમાંગ ઉઠી છે. વરસવાનું શરૂ થઈ ગયું હતું. બે કલાકના નવા નક્કોર બ્લોક રોડના એક જ દિવસમાં હાલ બેહાલ

નવી દિલ્હી, તા.૨ આરબીઆઈ ગવર્નર શક્તિકાંત દાસે યુપીઆઈના વૈશ્વિક વિસ્તરણ માટે આશાવાદ વ્યક્ત કર્યો, કહ્યું કે ભવિષ્યમાં આંતરરાષ્ટ્રીયકરણ કરવાની યોજના છે. રિઝર્વ બેંક ઓફ ઈન્ડિયાના ગવર્નર શક્તિકાંત દાસે તાજેતરની પ્રેસ બ્રીફિંગ દરમિયાન યુનિફાઈડ પેમેન્ટ્સ ઈન્ટરફેસના ભાવિ વૃદ્ધિ અને વૈશ્વિક વિસ્તરણ અંગે આશાવાદ વ્યક્ત કર્યો હતો. દાસ, જેઓ હાલમાં રાજ્યની પાંચ દિવસની મુલાકાતે છે, તેમણે ઊઇ કોડ્સ અને ઝડપી ચુકવણી સિસ્ટમ લિંકેજ દારા UPI ની પહોંચને વિસ્તારવા માટે ઘણા દેશો સાથે ચાલી રહેલી ચર્ચાઓને પ્રકાશિત કરી. દાસે જણાવ્યું હતું કે, અમે આશા રાખીએ છીએ કે આ આંતરરાષ્ટ્રીયકરણ થશે.

મુંબઈમાં એક કાર્યક્રમમાં બોલતા, ઓફ ઈન્ડિયા ના ગવર્નર શક્તિકાંત ULI ની પરિવર્તનશીલ સંભાવનાને દાસે નોંધ્યું હતું કે UPI અને દાસે સમગ્ર ભારતમાં 'યુનિફાઈડ પ્રકાશિત કરી.

RuPay કાર્ડને આંતરરાષ્ટ્રીય સ્તરે લેન્ડિંગ ઈન્ટરફેસ' ટેકનોલોજી પ્લેટફોર્મ લોન્ચ કરવાની યોજના જાહેર કરી હતી.

ગોલ્ડ રિઝર્વની વાત આવે તો અમેરિકાનું નામ હંમેશા ટોચ પર આવે છે. અમેરિકા પાસે વિશ્વની સૌથી વધુ ૮૧૩૩ ટન ગોલ્ડ રિઝર્વ છે. ત્યાર બાદ જર્મની પાસે અમેરિકાના ૩૦ ટકા ગોલ્ડ રિઝર્વ છે. જો ભારતની વાત કરીએ તો રિઝર્વ બેંક પાસે અમેરિકાની તુલનાએ ૧૦માં ભાગનું ગોલ્ડ છે. પરંતુ ભારતીય પરિવારો પાસે એટલુ બધુ સોનું છે કે, તે અમેરિકાની સંપૂર્ણ ગોલ્ડ રિઝર્વ ખરીદી શકે છે.અમેરિંકાની ફેડ રિઝર્વ પાસે ૮૧૩૩ ટન ગોલ્ડ રિઝર્વ છે, જ્યારે બીજા ક્રમે જર્મની પાસે ૩૫૫૩ ટન ગોલ્ડ રિઝર્વ, ઈટલી પાસે ૨૪૫૨ ટન ગોલ્ડ રિઝર્વ છે. અને આરબીઆઈ પાસે ૮૦૦ ટન ગોલ્ડ રિઝર્વ છે. ગોલ્ડ રિઝર્વ મામલે ભારત વિશ્વમાં નવમા ક્રમે છે.

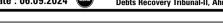
