Consequent to our intimation dated October 3, 2024, we wish to inform you that KNR Constructions Limited (the "Company") has entered into Share Purchase Agreement dated October 29, 2024 for transfer of its entire stake i.e. 0.65% in KNR Muzaffarpur Barauni Tollway Private Limited (hereinafter referred to as the "SPV") to JKM Infra Projects Limited and/or Mr. Gaurav Jalan (Promotor and Director of JKM Infra Projects Limited) (the "Investor")

The Company has invested Rs 45.90 lakhs (in form of equity) against which the Company is expected to receive Rs. 45.90 lakhs through this transaction subject to final valuation of the SPV.

The details of the transaction are provided in Annexure I hereto.

Further, KNRC Holdings and Investments Pvt Limited (the "KHIPL"), the wholly owned subsidiary of the Company has entered into Share Purchase Agreement dated October 29, 2024 for transfer of its entire stake i.e. 100% in KNR Muzaffarpur Holdings Private Limited (hereinafter referred to as the "KMHPL") to JKM Infra Projects Limited and/or Mr Gaurav Jalan (Promotor and Director of JKM Infra Projects Limited) (the "Investor")

The KHIPL has invested Rs 1.00 lakh (in form of equity) against which KHIPL is expected to receive Rs. 1.00 lakh through this transaction subject to final valuation of the KMHPL.
