Subject: Update on litigation - Disclosure under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015

We refer to our intimation dated April 21, 2024, wherein the Company had informed stock exchanges regarding receipt of an order from Assistant Commissioner, Office of the Special Commissioner, Large Taxpayers' Unit, Kolkata-15. The Company had filed an appeal against the said Order.

The Company has now received an order from the Additional Commissioner, Large Taxpayer Unit, West Bengal (Appellate Authority) on October 29, 2024 at 12:25 p.m., confirming the GST demand of ₹ 5,26,484/-, Interest of ₹ 3,84,389/- and levying Penalty of ₹ 58,970/-. The Company would pursue an appeal / evaluate other legal options against the said Order.

The details of the said Order as required under Clause 20 of Para A of Part A of Schedule III of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with SEBI Circular dated July 13, 2023 are enclosed herewith as an **Annexure 1**.
