Sub: Intimation of Board Meeting for raising of fund by issuance of Non-Convertible **Debentures (NCDs)**

Pursuant to Regulation 29 and Regulation 50 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, it is hereby informed that a meeting of the Board of Directors of the Bank is scheduled to be held on Saturday, February 22, 2025 inter-alia to consider / approve the proposal for raising of funds by way of issuance of non-convertible debentures in the form of Basel III compliant Tier-II Bonds, subject to the requisite approvals of Regulators / Shareholders.
