Sub: Intimation under Regulation 30 of the SEBI (Listing Obligations and Disclosures Requirements) Regulations, 2015 - Temporary shutdown of furnace at Hindusthan National Glass & Industries Limited at its plant being Furnace No. 9 at Puducherry.

In terms of Regulation 30 of SEBI (Listing Obligations and Disclosures Requirements) Regulations, 2015 ('SEBI LODR Regulations'), we hereby wish to inform you about an operational decision regarding our Glass manufacturing facility located at Puducherry.

Summary:

Post the 31st CoC meeting and on the basis of the pattern during the e-voting which stood concluded on 2nd September 2024, the CoC members have taken a decision to rebuild Furnace no. 9 at Puducherry.

The Company further is in receipt of an assessment visit report dated 29th November 2024 from an expert technical agency. The assessment report has recommended that given the delivery lead time involved in procurement of refractories, which is approx. 5-6 months, there is considerable time lag until ordered materials are received and furnace can be taken up for rebuild. Hence, given the critical nature of the said turnace, it is advised to explore the possibility of temporarily shutting down the furnace till the time same is taken up for rebuild.

The assessment report was discussed during, the 33rd meeting of the Committee of Creditors ("CoC") of Hindusthan National Glass & Industries Limited, and the CoC members took a decision to temporarily shut down Furnace No. 9 at Puducherry until the refractory materials are delivered and the rebuild of the furnace is completed, keeping in view safety of the personnel deployed at the plant as well as the assets at the plant. It is important to note that the CoC members further added that no employee should be retrenched due to the temporary shut down and should continue to receive payments in accordance with his/her agreement with the Corporate Debtor.

Therefore, an action to temporarily shut down Furnace No. 9 at Puducherry has been initiated today i.e. 21.12.2024. The operational disruption caused due to closure of Furnace No. 9 at Puducherry may be considered as a material event and thus the Company is making the disclosure as per Regulation 30(4) SEBI LODR Regulations.
