Scrutinizer's Report of the votes cast "IN FAVOUR" or "AGAINST" the businesses set out in the Notice of AGM, based on the reports generated from the e-voting system of National Securities Depository Limited ("NSDL"), the authorized agency to provide remote e-voting facility engaged by the Company, and votes casted during the AGM.

- 3. Further to above, I submit my report as under:
  - 3.1 The Company had uploaded the Notice of the 40<sup>th</sup> AGM containing all the items of businesses to be transacted on the website of the Company and NSDL and also on the website of the stock exchanges i.e., BSE Limited and National Stock Exchange of India Limited, to facilitate their shareholders to cast their vote.
  - 3.2 The Notice of the 40<sup>th</sup> AGM containing the detailed procedure to be followed by the Members who were desirous of casting their votes electronically as provided under Rule 20 of the Companies (Management and Administration) Rules, 2014 read with amendments made thereto and MCA circulars and Annual Report for the Financial Year 2023-24 were sent through e-mail to the Members whose names appeared in Register of Members of the Company.
  - 3.3 In compliance with the said Rules and the MCA circulars, the Company had published an advertisement in the Newspapers regarding the intimation of 40<sup>th</sup> AGM to be at the registered office of the Company and specifying the dispatch of Notice of 40<sup>th</sup> AGM along with Annual Report.
