We wish to inform you that the Board of Directors of R K Swamy Limited ("the Company") at their meeting held on Friday, May 24, 2024 had recommended a Final Dividend of Rs. 2 per equity share having face value Rs. 5 for the financial year ended March 31, 2024 subject to approval of the shareholders at the ensuing Annual General Meeting.

The dividend, as recommended by the Board and if approved at the ensuing Annual General Meeting of the Company to be held on Monday, August 19, 2024, will be payable to those shareholders whose name appear in the Register of Members of the Company or in the records of the Depositories as beneficial owners of the shares as on the record date i.e. Sunday, August 11, 2024.

Pursuant to the SEBI master circular no. SEBI/HO/MIRSD/POD-1/P/CIR/2024/37 dated May 07, 2024, it is mandatory to furnish PAN, KYC Details (including email, mobile number, and bank account details) and Nomination. Kindly ensure these details are updated.

For registering the Bank account details / Mobile Number / Email ID / PAN/Nomination, request you to contact your respective depository participant and update the KYC & Bank a/c details in your demat account.

In accordance with the provisions of the Income Tax Act, 1961 ("the Act"), as amended by and read with provisions of the Finance Act, 2020, the dividends declared and paid by a Company are taxable in the hands of the shareholders. Therefore, the Company is required to deduct Tax at Source (TDS) on the distribution of dividend income at applicable rates. The TDS rate may vary depending upon the availability of valid PAN, residential status, category of shareholder, etc. and is subject to provision of requisite documents / declarations received by the Company. Please note that these details as available on record date in the Register of Members will be relied upon by the Company, for the purpose of complying with the applicable TDS / withholding tax provisions. The rate of TDS / withholding tax provisions, applicability of exemption (if any) along with documents required for various categories of shareholders are enumerated below –

2. **The aforesaid requisite documents as applicable to your case can be uploaded on the link <https://ris.kfintech.com/form15/> on or before Monday, August 12, 2024. Any communication received after the above mentioned cut-off date will not be considered, for deduction of applicable tax. Where copies of the documents are required, such copies should be self-attested by the shareholder or its authorized signatory.**
3. You may also utilize the online application developed as per SEBI guidelines and accessible by registering with First Holder PAN at the URL: <https://kprism.kfintech.com/signup>
4. The documents furnished by the shareholders (such as Form 15G/15H, TRC, Form 10F, Self-Attested Declaration, etc.) shall be subject to review and examination before granting any beneficial rate or NIL Rate.
5. The Company reserves the right to reject the documents in case of any discrepancies or the documents are found to be incomplete. In such cases, the Company reserves the rights to rely on its independent assessment and deduct tax at higher rates as per applicable provisions.

6. As per the provisions of Section 206AB of the Act, if any TDS is deductible from a "specified person", then, TDS would be deducted at higher of the following rates-
- a. twice the rate specified in the relevant provision of the Act;
 - b. Twice the rate or rates in force;
 - c. At the rate of 5%. For the above purpose, "specified person" means a person, being a resident or a non- resident having a Permanent Establishment (PE) in India
 - a. Who has not furnished the return of income for the assessment year relevant to the previous year immediately preceding the financial year in which tax is required to be deducted. For this purpose, the assessment year would be reckoned to be the one for which time limit for filing Return of Income under sub-section (1) of section 139 has expired; and
 - b. The aggregate of TDS/TCS deducted/collected in the case of such person is Rs.50,000 or more in the said previous year.
7. Benefit under Rule 37BA:- In case where shares are held by Clearing Member/ intermediaries/ stock brokers and TDS is to be applied by the Company in the PAN of the beneficial shareholders, then intermediaries/ stock brokers and beneficial shareholders will have to provide a declaration specified format.
8. Accordingly, if, at the time of deducting TDS, the status of a resident shareholder or a non-resident shareholder (having a PE in India), as shown by the system of the Income-tax Department, is a "specified person", TDS would be deductible at twice the normally applicable rate or 5%, whichever is higher.

Further, if owing to non-availability of PAN of a shareholder who is a "specified person" under section 206AB of the Act, the provisions of section 206AA are also applicable, TDS would be deductible at the rate applicable under section 206AA or under section 206AB of the Act, whichever is higher.

In the cases of resident shareholders, if PAN of a shareholder is not updated, it shall be assumed that the shareholder is a "specified person" for the purpose of section 206AB of the Act and TDS would be regulated accordingly.

It may be noted that, the provisions of Section 206AB shall not be applicable in the cases of non-resident shareholders not having a PE in India. For this purpose, the expression PE (i.e., permanent establishment) includes a fixed place of business through which the business of the non-resident is wholly or partly carried on.

Thus, if a non-resident shareholder, who is otherwise liable for higher TDS under Section 206AB, submits a duly signed and verified declaration confirming that he/she does not have a PE in India, the provisions of Section 206AB would not come into play and TDS would be deductible at the normally applicable rate. In absence of such a declaration, TDS would be regulated as per the provisions of section 206AB of the Act.

9. In case of tax deducted at a higher rate, the shareholder shall have the option to file return of income and claim appropriate refund from the Income Tax Authority. No claim shall lie against the Company for the taxes deducted.
10. In the event of any income tax demand (including interest, penalty, etc.) arising from any misrepresentation, inaccuracy or omission of information provided by the shareholder, the shareholder will be responsible to indemnify the Company and also, provide the Company with all information / documents and co-operation in any tax proceedings. In case dividend income is assessable in the hands of person other than member, then declaration in the specified format needs to be provided by member for the same as per Rule 37BA of the Income Tax Rules, 1962.
11. The Company will issue soft copy of the TDS certificate to its shareholders through email registered with the Company / RTA post payment of the dividend. Shareholders will be able to download the tax credit statement from the Income Tax Department's website <https://www.incometax.gov.in> (refer to Form 26AS).
