

The Company has entered MOU with retrenched workers/labourers, initialted maintenance of plant and increased investment in inventories to resume plan operation shortly. The company's liquidity position is very healthy and its liquid assets are far higher than its liabilities. In light of above, the company doe: not envisage any threat to going concern status of the company and hence, the financial results have been prepared on going concern basis
