Suhas, Thulasimathi bag silver medals

Nitesh clinches gold in paralympic badminton

Big medal haul; Nithya, Manisha get bronze

Paris, Sep 3: Nithya Sre Sivan won the bronze medal for India in the newly-introduced women's singles badminton SH6 class at the Paris 2024 Paralympics on Monday.

It was India's eighth medal of the day and fifth in badminton, all won on the same day. India won four medals in badminton at the Tokyo 2020 Paralympics.

The 19-year-old Nithya, who came into the tournament as a top seed, dominated Indonesia's Rina Medina to win the contest 21-14, 21-6 in just 23 minutes.

The Indian shuttler made the bronze medal match after she was beaten by the People's Republic of China's Lin Shuangbao 21-13, 21-19 in the SH6 semi-finals.

Athletes competing in the SH6 class have short stature and play in standing positions. S in SH stands for 'standing' while H stands for 'short stature'.

Earlier in the day, Indian badminton player Nitesh Kumar won the gold medal in the men's singles SL3 class. Suhas Yathiraj won silver in the men's singles SL4 Thulasimathi Murugesan



and Manisha Ramadass won silver and bronze, respectively, in the women's singles SU5 class.

Nitesh, the 29-year-old Indian para-badminton player took one hour and 20 minutes to win the title, ensuring India's second straight gold medal in the SL3 class event. Pramod Bhagat won the gold medal at Tokyo 2020 in the same class with a win over the same opponent.

Interestingly, It was Nitesh Kumar's first win over Daniel Bethell in 10 attempts. The British badminton player threatened to keep his unbeaten run alive with a late surge in the third game but the

world No. 1 Indian held his nerves to clinch a gold medal on his Paralympic Games debut.

"Even before stepping onto the court, I knew it was going to be a mental game. I just wanted to keep my calm and that worked for me in the first set," Nitesh Kumar, a graduate from the Indian Institutes of Technology, said after the match.

Nithya's Paralympic medal took India's tally at Paris 2024 to 15. It is only the second time in the Paralympics history that India have crossed the 10-medal mark.

India won 19 medals, including five golds at the Tokyo 2020 Paralympics

for their best show in the competition. At Paris 2024, India have won three gold medals so far. Indian parathlete Nishad Kumar has once again demonstrated his exceptional talent by securing a silver medal in the men's high jump T47 event, which includes athletes with upper limb impairments, muscle power deficiencies, or restricted passive range of movement.

This remarkable achievement marks India's seventh medal at the Games and adds to Nishad's impressive record as herepicates his silver medal performance from the Tokyo 2020 Paralympics.

silver and 3 bronze and got second place. Tanjore team bagged 5 gold, 10 silver on 3 bronze got 3rd place.

Chennai, Sep 3: Defending champions Athlead Goa Challengers inched closer to the semi-finals with a narrow 8-7 win against U Mumba TT in a closely-contested IndianOil Ultimate Table Tennis 2024 tie at the Jawaharlal Nehru Indoor Stadium in Chennai on Monday.

Athlead Goa Challengers are now in third place on the league table with 37 points, while U Mumba TT are placed fourth with

36 points. On Tuesday, former champions Chennai Lions will lock horns with Puneri Paltan Table Tennis with one eye on making it to the last-four stage.

In the first men's singles, Quadri Aruna edged out Harmeet Desai 2-1 (11-7, 4-11, 11-10) in a tight contest to hand U Mumba TT the early advantage.

Maria Xiao, who was later adjudged the Foreign Player of the Match,

bolstered the lead for U Mumba TT with a 2-1 (9-11, 10-11, 11-9) win in the first women's singles against Yangzi Liu, who has now lost three matches on the trot this season.

Yangzi Liu made amends when she joined Harmeet Desai to beat the U Mumba TT pair of Maria Xiao and Manav Thakkar 2-1 (11-6, 10-11, 11-7) in the mixed doubles match to reduce the deficit for Athlead

Goa Challengers.

Mihai Bobocica came up with an impressive performance to beat the talented Manav Thakkar 2-1 (11-6, 11-8, 7-11) as Athlead Goa Challengers drew level at six points each. Yashaswini Ghorpade, who was deservingly adjudged the Indian Player of the Tie, sealed the tie in favour of the defending champions with a 2-1 (11-8, 11-10, 10-11) victory against Sutirtha Mukherjee.
