Opinion

We have audited the accompanying standalone Half Yearly and year to date Financial Results of Amanaya Ventures Limited (the "Company") for the Half Year and Year ended March 31, 2023, ("Statement"), attached herewith, being submitted by the Company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ("Listing Regulations").
