Sub.: Allotment of 36,58,02,500 Fully Convertible Warrants

Dear Sir / Ma'am,

We are pleased to inform that the Company's preferential issue of 48,13,42,500 Fully Convertible Warrants ("Warrants") has been successfully completed today. The issue was almost fully subscribed (99.89%) i.e. 48,08,02,500 Warrants amounting to an issue size of ₹ 2,702.11 crore have been subscribed by the Proposed Allottees including Promoter Group.

Further, pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and in continuation to our earlier intimation dated September 30, 2024 regarding allotment of 11,50,00,000 Warrants by way of preferential allotment on private placement basis to two of the Proposed Allottees belonging to Promoter Group category, we would like to further inform that the Board of Directors of the Company vide a resolution passed by Circulation on October 11, 2024 has allotted 36,58,02,500 (Thirty Six Crore Fifty Eight Lakh Two Thousand Five Hundred) Warrants by way of preferential allotment on private placement basis to 114 Proposed Allottees belonging to 'Promoter' Group' and 'Non-Promoter', Public Category', after receipt of stipulated amount i.e. 25% of the Issue Price as subscription amount in accordance with the provisions of the SEBI (Issue of Capital and Disclosure Requirements) Regulations, 2018 ("ICDR Regulations").

Each of the Warrant, so allotted, is convertible into 1 equity share having face value of ₹ 10 (Rupees Ten Only) each, fully paid up, of the Company in accordance with the provisions of ICDR Regulations, on payment of the balance consideration i.e. 75% of the Warrant Issue Price by the Allottees within 18 months from the date of allotment of these Warrants. However, Warrant holders shall be entitled to any corporate action such as issuance of bonus shares, right issue, split or consolidation of shares etc. announced by the Company between the date of Warrants allotment and their conversion into equity shares.

The requisite details pursuant to Regulation 30 - Part A of Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with SEBI Circular No. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023 are enclosed as **Annexure – 1**.

All the Directors approved the resolution and the approval form the last Director was received at 5:15 P.M. today.
