

केजरीवाल गेले पुढे काय?

दिल्लीच्या निवडणुकीत अखेर आम आदमी पक्षाला नमवून २७ वर्षानंतर भाजप सत्तेत परतली आहे. एकेकाळी काँग्रेसला आव्हान देत देशाची राजधानी आपल्या ताब्यात ठेवणाऱ्या भाजपने त्या जोरावर संपूर्ण देशात आपले वातावरण निर्माण केले होते. मात्र संपूर्ण देशभर जेव्हा भाजपचे वातावरण निर्माण झाले तेव्हा दिल्लीत त्यांची सत्ता नव्हती हे वास्तव भाजप नेत्यांना डाचत होते. त्यामुळेच उपराज्यपालाच्या हाती ही शक्ती सोपवून त्यांनी केजरीवाल यांच्या उधळलेल्या वारूला लगाम घातला होता. मात्र आता उपराज्यपालाचे महत्त्व किती राहते, दिल्लीच्या मुख्यमंत्र्याला एक विशेष दर्जा प्राप्त होतो का हे लवकरच दिसेल. भाजपसाठी हे छोटेसे राज्य सुद्धा खूप महत्त्वाचे होते आणि ते अपेक्षेप्रमाणे त्यांनी जिंकून दाखवले आहे. हा भाजपच्या निवडणुक व्यवस्थापन तंत्राचा आणखी एक मोठा विजय आहे, ज्याने संपूर्ण भारताला आश्चर्यचिकत करून ठेवले आहे. देशातील एकमेव इमानदार आणि चारित्र्यसंपन्न नेता अशी स्वतःची प्रतिमा निर्माण करण्यात केजरीवाल यांना पहिल्या निवडणुकीतच यश आले होते. लोकपाल आंदोलनामुळे सत्तेत आलेल्या या पक्षाला पहिल्या निवडणुकीत इतर पक्षांच्या कुबड्यांची गरज लागली होती मध्येच त्यांनी त्या कुबड्या फेकून निवडणुकीला सामोरे जाण्याचे आव्हान स्वीकारले होते. तेव्हापासूनच्या दोन निवडणुकांमध्ये भाजप आणि काँग्रेस या दोन पक्षांचा सुपडासाफ करून दिल्लीने केजरीवाल यांच्याकडे ६७ आणि ६२ इतक्या संख्येने एकतर्फी सत्ता सोपवली होती. २०२० मध्ये केवळ आठ जागा जिंकलेल्या भाजपला दिल्लीकरांनी २०२५ मध्ये ४८ जागांवर विजयी केले आहे. हा सत्ताविरोधी निकाल म्हणावा की भाजपच्या सर्वत्र यशस्वी होणाऱ्या निवडणुक तंत्राचे यश? यावर मतमतांतरे घडतील. काँग्रेस नेत्यांचे निकालानंतर युती करण्याच्या आवडत्या अडवणुकीच्या राजकारणाचेही मनसुबे उधळले गेले. दहा वर्षे दिल्लीवर एकहाती राज्य केल्यावर अरविंद केजरीवाल यांचा किल्ला अचानकपणे ढासळला आणि नुसता ढासळलाच नाही तर पत्त्याच्या बंगल्याप्रमाणे कोसळला. स्वतः केजरीवालच केवळ विधानसभा निवडणुकीत हरले नाहीत तर त्यांच्या छोटेखानी पक्षाचे अतिरथी महारथी देखील धारातीर्थी पडले. केजरीवाल यांचे उजवे हात समजले जाणारे मनीष सिसोदिया देखील हरले तसेच सत्येंद्र जैन देखील. केजरीवाल म्हणजे आम आदमी पक्षाचा एकखांबी तंबू. तोच कोसळल्याने आता पक्षाची सारी सर्कसच डुबणार आहे हे सांगायला कोणाही राजकीय पंडिताची गरज नाही. अण्णा हजारे यांच्या भ्रष्टाचारविरोधी आंदोलनातून २०१२-१३ मध्ये पुढे आलेल्या केजरीवाल यांनी कल्याणकारी योजनांची कास धरून राजधानीत आपली एक मतपेढी तयार केली होती. त्यामुळे काँग्रेसचे दिल्लीतील दुकानच बसले होते तर भाजपची दमछाक केलेली होती. पर्यायी राजकारणाचा दूत म्हणून राजकारणात आलेले केजरीवाल हे दशकभरात नेहेमीचाच नेता बनले आणि त्यांची घसरण सुरु झाली. मोदी यांनी आप म्हणजे 'आपदा' आहे अशी केजरीवाल यांच्या पक्षाची संभावना करून त्यांची अजूनच अडचण करून टाकली. केजरीवाल यांनी स्वतःला पक्षाचा सर्वेसर्वा बनवण्याकरता त्यांनी योगेंद्र यादव, प्रशांत भूषण आणि कुमार विश्वास या ज्येष्ठ नेत्यांची हकालपट्टी केली आणि पक्षात होयबांचा सुळसुळाट केला.

दोन वर्षांवर गुजरात आणि पंजाबच्या निवडणूक आहेत. पंजाबमधील आपचे सरकार आता लवकरच अडचणीत येण्याची शक्यता नाकारता येत नाही. भगवंत मान हे तेथील मुख्यमंत्री हे केजरीवाल यांच्या हातातील बाहुले आहेत असा सर्वदूर संदेश गेला होता. नवीन परिस्थितीत केजरीवाल यांना पंजाबवर पहिल्यासारखी पकड ठेवता येणार नाही आणि तेथील स्थानिक नेते देखील आपल्या भविष्याविषयी साशंक होणार हे साहजिकच आहे. काँग्रेसचे वाढलेले मत हे केजरीवाल यांना हरवण्यात उपयोगी ठरलेले आहे. गुजरातची विधानसभा निवडणुक असो अथवा हरयाणाची, सगळीकडे केजरीवाल यांनी काँग्रेसचे वोट कटवा म्हणन काम करून भाजपला जबर मदत केली होती याची राहुलना जाणीव होती. स्वतःला सगळ्यात हुशार समजून इतरांना बुद्धु बनवण्याचा केजरीवाल यांचा कार्यक्रम त्यांच्या अखेरीस अंगलट आला.

'आम्ही राजकारणात सत्तेकरता आलेलो नाही. लोकांच्या सखदःखात सामील करण्याकरता आलो. आमचा पक्ष एक विधायक विरोधी पक्ष म्हणून काम करेल' असे केजरीवाल यांनी सांगितले असले तरी त्यांना लवकरच तरुंगाची हवा खावी लागेल असे राजकीय वर्तळात मानले जात आहे. ज्या दिवशी केजरीवाल यांना मुख्यमंत्री असतानाच अटक झाली त्याचदिवशी येती निवडणूक आम आदमी पक्षाला जड जाणार हे ठरले होते.

गमतीची गोष्ट अशी की जेव्हा जेव्हा महिला मख्यमंत्री होत्या तेव्हा त्यांचा पक्ष हरला. १९९८ साली सुषमा स्वराज या मुख्यमंत्री असताना भाजप हरली होती. तीन वेळा मुख्यमंत्री राहिलेल्या शीला दीक्षित तसेच आता आपच्या आतीशी त्या स्वतः ही निवडणुक जिंकल्या आहेत. गेल्या दोन निवडणुकात ५० टक्क्यांपेक्षा जास्त मते मिळवणारा आम आदमी पक्ष यावेळी धास्तावलेला होता. केजरीवाल यांना तुरुंगाची हवा खायला लागल्यावर 'आगळावेगळा पक्ष' ही त्या पक्षाची ओळखच धोक्यात आली. केजरीवाल यांच्या स्वतःच्या मतदारसंघात गेल्या पाच वर्षात त्यांचा जनसंपर्क फारसा राहिला नव्हता. दिल्लीमध्ये जे काय घडले ते अरविंद केजरीवाल यांच्यावरील जनमतसंग्रह होता. ते मुख्यमंत्री होणार की हरणार या मुद्यावरील ही लढाई होती. ते जिंकले तर त्यांचे केजरीवाल मॉडेल हे नरेंद्र मोदी मॉडेलपेक्षा वरचढ आहे, सरस आहे असा डांगोरा त्यांनी पिटला असता. विरोधी पक्षांच्या इंडिया आघाडीचे नेतृत्व करण्यासाठी देखील त्यांनी तिकडमबाजी केली असती. नवीन परिस्थितीत मात्र आपचा अध्याय कितपत टिकणार याबाबत साशंकता आहे. केजरीवाल यांना मुख्यमंत्री म्हणून हॅट्रिक करता आलेली नाही. पुढील वर्षी ममता बॅनर्जी हॅट्टिक करू शकणार काय याबाबत प्रश्नचिन्ह निर्माण झालेले आहे. महाराष्ट्र, हरियाणा आणि दिल्लीतील भाजपच्या विजयाने बिहारच्या निवडणुकीत नितीश कुमार यांना सबुरीने घ्यावे लागणार आहे.

जमनालाल बजाजः एक ख्यातनाम उद्योगपती!

जमनालालजी बजाज यांनी स्त्रीशिक्षणास अग्रक्रम देऊन स्त्रियांना समान हक्क मिळवून देण्याचा प्रयत्न केला. त्याकरिता वर्धा येथे त्यांनी मारवाडी शिक्षण मंडळाची स्थापना केली. तसेच गांधींच्या मूलोद्योग शिक्षणावर भर दिला आणि राष्ट्रीयतेची भावना जोपासली व अस्पृश्यतानिवारणाचे महान कार्य अंगीकारले. त्यांनी खिलाफत चळवळीतही भाग घेतला होता. अखेरच्या दिवसांत सेवाग्राम आणि गोसेवासंघ या कार्यास त्यांनी स्वतःला वाहून घेतले होते. गांधीवादी मार्गाने स्वराज्य मिळेल, यावर त्यांची दृढ श्रध्दा होती. म्हणूनच त्यांनी खादी, ग्रामोद्योग व गोसेवा यांचा पुरस्कार केला. जमनालालजी बजाज यांचा जन्म राजस्थानमधील सिकल जिल्ह्यातील कासी का बास या गावात दि.४ नोव्हेंबर १८८९ मध्ये झाला. अवघ्या चार वर्षांचे असताना वर्ध्याचे सेठ बच्छराज बजाज यांनी नातु म्हणून दत्तक घेतले. बच्छराज यांचा वर्धा शहर आणि विदर्भात कापसाच्या रुई गाठींचा व्यवसाय होता. जमनालालजी यांचा वयाच्या तेराव्या वर्षी जानकीदेवी यांच्यासोबत विवाह झाला. त्यावेळी बालविवाहाची प्रथा सर्वत्र प्रचलित होती. जमनालाल व जानकीदेवी या दाम्पत्याने पुढे मात्र या प्रथेविरोधात मारवाडी समाजासह इतर समाजासाठी कार्य केले. जमनालाल यांना बालपणापासूनच विलासी जीवन, श्रीमंती आवडत नसे, ते यात रमत नसत. राष्ट्रवाद त्यांच्या नसानसात वसत होता. लोकमान्य टिळकांच्या केसरीचे ते वाचक होते. १३ वर्षाच्या जमनालाल यांनी आपल्या पॉकेटमनीची बचत करून दान म्हणून १०० रुपये या वर्तमानपत्राला पाठविले होते. या काळातच ते गांधीजींच्या दक्षिण आफ्रिकेतील चळवळीविषयी आकर्षित झाले. जेव्हा गांधीजी भारतात आले तेव्हा जमनालाल त्यांच्याशी भेटले आणि सतत संपर्कात राहिले. गांधीजींना सन १९३४मध्ये वर्धा, सेवाग्राम येथे आणून कर्मभूमी करण्यास भाग पाडले. त्यासाठी त्यांनी सेवाग्राम व वर्धा येथील मोठी जागाही दिली.

जमनालाल बजाज हे एक गांधीवादी देशभक्त व बजाज उद्योगसमूहाचे प्रवर्तक होते. त्यांचा जन्म पूर्वीच्या जयपूर संस्थानातील कासीकाबास या खेड्यात एका गरीब कुटुंबात झाला. वडील कनिराम व आई बिरदीबाई होत. वयाच्या चौथ्या वर्षी जमनालाल वर्ध्याचे बच्छराज
