Besides these cases, the YouTuber also faces a case lodged by the Theni Police for the alleged possession of 'ganja'.

tencing against the trio, Gaurav Chauhan, Ankur Singh and Sahi Ram and said that the offence was "heinous" and the trauma of the victim's family members

could be understood. The court also observed that the poverty of the convicts was not a mi-

tigating factor in the case where the aggravating factors far outweighed the mitigating factors.

The accused were earlier convicted under penal provisions for criminal conspiracy, kidnapping or abduction for ransom and criminal intimidation.
