Sub: Scrutinizer's Report on the Postal Ballot/meeting process conducted through remote e- Voting in respect of passing of resolutions set out in the Postal Ballot Notice dated 13th November 2024.

Dear Sir,

- I, Sourjya Prakash Mohapatra, Practicing Chartered Accountant, was appointed by the Board of Directors of Indian Metals & Ferro Alloys Limited ("the Company") as a Scrutinizer, to conduct the postal ballot/meeting through the process of remote evoting in a fair and transparent manner and ascertaining the requisite majority on postal ballot resolution through remote e-voting carried out pursuant to provisions of Section 233 and Section 110 of the Companies Act, 2013 ("the Act") read with Rule 22 and Rule 20 of the Companies (Management and Administration) Rules, 2014 ("the Rules") as amended from time to time, read with Circular No. 14/2020 dated 08.04.2020, Circular No. 17/2020 dated 13.04.2020, Circular No. 33/2020 dated 28.09.2020, Circular No. 39/2020 dated 31.12.2020, Circular No. 10/2021 dated 23.06.2021 General Circular No. 20/2021 dated 8th December, 2021, General Circular No. 03/2022 dated 5th May, 2022, General Circular No. 11/2022 dated 28th December, 2022 ,General Circular No. 09/2023 dated 25th September, 2023 and General Circular No. 09/2024 dated 19th September, 2024 issued by Ministry of Corporate Affairs (MCA) (hereafter collectively referred to as MCA Circulars) and as amended in respect of Special Resolution for approval of the Scheme of Amalgamation (the Scheme) between Utkal Coal Limited (Transferor Company) and Indian Metals & Ferro Alloys Ltd. (Transferee Company) and their respective members and creditors under Section 233 of the Companies Act, 2013.
- 2. The management of the Company is responsible to ensure the compliance with the requirements of the relevant provisions of:
 - (i) The Companies Act, 2013 and the Rules made thereunder including MCA circulars issued by MCA; and
 - (ii) SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 as amended from time to time

relating to postal ballot voting by voting by electronic means.

My responsibility as a Scrutinizer is restricted to making a Scrutinizer's Report of the votes cast by the members for the resolutions contained in the Notice dated 13th November 2024, based on the reports generated from the e-voting system provided by National Securities Depository Limited ("NSDL"), the authorized agency engaged by the Company to provide e-voting facilities.

4. The Postal Ballot Notice was issued to all the Members whose names appeared on the Register of Members/List of Beneficial Owners as received from National Securities Depository Limited (NSDL)/Central Depository Services (India) Limited (CDSL) as on 8th November 2024. In accordance with the MCA Circulars, the Company has sent the Postal Ballot/meeting Notice in electronic form only. Accordingly, the communication of the assent and dissent of the members took place through the remote e-voting system only.

The Notice along with Explanatory Statement under Section 102 of the Act was sent to the members of the Company through electronic mode to those members whose email addresses were registered with the Company/Depositories. However, the Company has also given an additional opportunity to its members to update their credentials with the Company through a public notice dated 13th November 2024. Further the Company vide the Postal Ballot notice dated 13th November 2024, had also requested its shareholders to register their email addresses with the Company. The shareholders holding shares as on the cut-off date i.e. 8th November, 2024 were entitled to vote on the proposed resolution as set out in the Notice dated 13th November, 2024:

5. The Company has availed of the e-voting facility offered by National Securities Depository Limited (NSDL) for conducting e-voting by members of the Company.

I submit my report as under:

- (i) On 13th November 2024, the Company completed the dispatch of postal ballot notice only through electronic mode to members whose e-mail ID was registered with the Company and whose name(s) appeared on the register of members/List of Beneficial Owners as on the cut-off date. For this purpose, we have relied upon the email exchanged by NSDL with the Company for confirming that the emailcommunication has been sent to all the members as mentioned above.
- (ii) An advertisement regarding notice of Postal Ballot/E-Voting was published in Business Standard (All edition) and Pragativadi (Odisha) dated 14th November2024.
- (iii) In compliance with MCA Circulars, physical Postal Ballot Forms were not dispatched by the Company. Therefore, neither the Company nor I have received any postal ballot (s).
- (iv) The shareholders have cast their votes through e-voting facility on the designated website URL: https://www.evoting.nsdl.com/
- (v) The remote e-voting for postal ballot process commenced on Thursday, 14th November, 2024 (9:00 A.M. IST) and ended on Friday, 13th December, 2024 (5:00 P.M. IST).
- (vi) All the votes received up to 5:00 PM on 13th December 2024, being the last date and time fixed by the Company for remote e-voting, were considered for my scrutiny. The e-voting was disabled immediately thereafter.
- (vii) 274 Number of members had cast their votes on e-voting platform till 13th December, 2024 5:00 P.M. IST.

(viii) The results of remote e-voting were unblocked by me by accessing the data downloaded by me from the website www.evoting.nsdl.com of NSDL. The votes were unblocked by me at 5:03 p.m. on 13th December 2024, in the presence of two witnesses, Ms Sunita Maharana and Mr Manoj Kumar Behera resident of Bhubaneswar, Odisha who are not in the employment of the Company. They have signed below confirming the votes being unblocked in their presence.
