This is with reference to the captioned subject, I Gandhi Nishant, Promoter of the Company and presently holding NIL equity shares. Further I also confirm that


- 1) I shall continue to comply with the conditions mentioned at sub-clauses (i), (ii), (iii) of clause (b) of Regulation 31A (3) of SEBI (Listing Obligation and Disclosure Requirement), Regulations 2015 at all-time from the date of re-classification, failing which, I shall be reclassified as promoter group of the Company.
- 2) I shall comply with the condition mentioned in the sub-clauses (iv), (v) of clause (b) of Regulation 31A (3) of SEBI (Listing Obligation and Disclosure Requirement), Regulations 2015, for a period of not less than three- year from the date of reclassification, failing which, I shall be reclassified as promoter group of the Company.
