Mumbai, India, November 08, 2024: - Knowledge Marine & Engineering Works Ltd. (KMEW) (BSE: 543273) has been awarded a work order by the Dredging Corporation of India (DCI) for the 'Development and Maintenance of fairway in various National Waterways in Barak River (NW-16) from Bhanga to Badarpur. The contract is for a period of 3 years and is valued at ₹ 39,53,00,000 (Rupees Thirty Nine Crore Fifty Three Lakh Rupees Only) inclusive of taxes.

A major milestone has been achieved with the successful award of the maiden contract in the Barak River (NW-16). This marks a significant step in expanding operations into a new national waterway, further strengthening the company's position in the inland waterways sector. The contract, awarded by Dredging Corporation of India (DCI), highlights the company's reputation as a preferred partner, reflecting its strong execution capabilities and robust asset base. The Inland Waterways Authority of India (IWAI) has entrusted Dredging Corporation of India (DCI) with the development and maintenance of the fairway for the Bhanga to Badarpur stretch. The recent contract award for this critical segment highlights a significant achievement, contributing to the enhancement of navigational infrastructure in this vital waterway.
