Subject: Reminder to update KYC details pursuant to SEBI Circular bearing reference nos. SEBI/HO/MIRSD/POD-1/P/CIR2023/181 dated 17<sup>th</sup> November, 2023 & SEBI/HO/MIRSD/MIRSD/POD-1/P/CIR/2023/37 dated Mach 16, 2023 (now rescinded due to issuance of Master Circular dated 07<sup>th</sup> May, 2024 ) and SEBI directive vide email to RTA on 17.01.2024

We refer to the above circulars issued by SEBI from time to time, that mandates all listed companies to record PAN, Address with PIN Code, Mobile Number, Bank Account details, Specimen signature and nomination of holders of physical securities. Email id is optional, however the security holders are requested to register email id also to avail online services.

This is applicable to security holders holding shares in physical mode.

**The salient features and requirements of the circulars are as follows.**

In case of non updation of above details in respect of physical folios, dividend/interest etc. shall be paid only through electronic mode with effect from 01<sup>st</sup> April, 2024 upon furnishing all the aforesaid details in entirety.

If the security holder updates the PAN, Choice of Nomination, Contact Details including Mobile Number, Bank Account Details and Specimen signature after 01<sup>st</sup> April, 2024, then the security holder would receive all the dividend / interest etc. declared during the period from 01<sup>st</sup> April, 2024 till date of updation pertaining to the securities held after the said updation automatically.

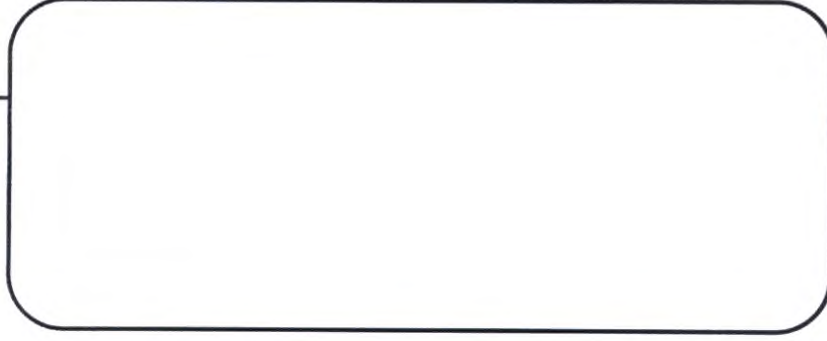
