MGEL/CS/NSE/2024-25/16, dated June 18, 2024 and with reference to the above captioned subject matter, we would like to inform you that Mangalam Global Enterprise Limited ("MGEL/the Company") has completed the procedures on November 18, 2024 for purchasing Plant & Machinery and Buildings from Shree Gurukrupa Oil and Foods ("Partnership Firm") and lands admeasuring 19833 square yards bearing Survey Nos. 186, 188 & 189 (collectively known as "Assets") from the individual land owners at Taluka: Jotana, Mehasana, Gujarat.
