Notes to the Standalone & Consolidated Unaudited Financial Results for the Quarter ended 30th June 2024:

- The above standalone and consolidated unaudited financial results for the quarter ended 30th June 2024 were reviewed by the Audit Committee and approved at the meeting of the Board of Directors of the Company held on 14th August, 2024 and subjected to limited review by the Statutory Auditors, who have expressed a modified opinion on the aforesaid results.
- The Company is principally engaged in a single business segment of manufacturing and trading of Iron & Steel and its related products, accordingly there is no separate reportable segment as per Ind AS 108 "Operating Segment".
- The results for the three months ended 31st March 2024 are derived from the audited accounts of the Company for the financial year ended 31st March 2024 and the year to date figures up to the first quarter of the respective financial year.
- 4. The associate of the Company has suffered substantial losses in the previous financial year as well as in the current quarter ending 30th June 2024, resulting in complete erosion of net worth of the associate, namely Hari Equipments Private Limited. In view of the same, 100% impairment of investments was provided by Dhatre Udyog Limited (Formerly, Narayani Steels Limited) in its accounts for the financial year ended 31st March 2020. However, the accounts of the associate company have been prepared on a going concern basis as the management of the associate is exploring the options to raise additional finance to revive the operations.
