Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we hereby inform you about a change in the Promoter Shareholding of the Company, Mr. Rajnit Rai Jain has acquired 3840 equity shares of the Company by way of transmission, following his claim of shares from the Investor Education and Protection Fund (IEPF).
