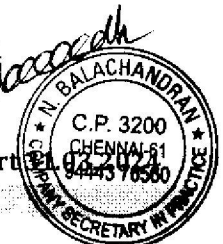

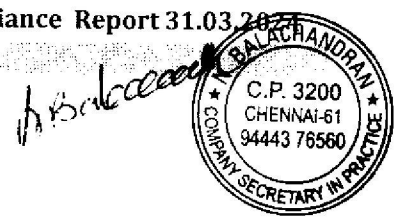
**Secretarial Compliance Report of Consolidated Construction Consortium Limited

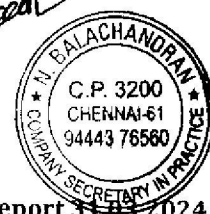

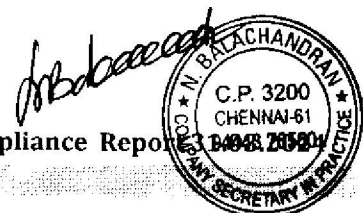
