In continuation of earlier intimations dated October 19, 2024, regarding the Order dated 18.10.2024 passed by the Ministry of Road Transport & Highways (MoRTH) disqualifying PNC Infratech Limited (“the Company”) and two SPVs namely PNC Khajuraho Highways Private Limited, PNC Bundelkhand Highways Private Limited from participating in any tender process of the Ministry for a period of one year with effect from 18.10.2024, the Company would like to intimate you that the Company and the two SPVs filed three separate Writ Petitions before the hon’ble High Court of Delhi challenging the aforesaid Order (Impugned Order) today i.e., on 21.10.2024 along with three separate applications requesting the hon’ble High Court to pass an ad-interim orders staying the effect, operation and implementation of the Impugned Order with immediate effect, till the disposal of Writ Petitions.
