Sub: Consolidated Scrutinizer's Report on voting done through Remote e-voting and e-voting at 37th (Thirty Seventh) Annual General Meeting of Pentokey Organy (India) Limited (the Company) held on Saturday,28th September, 2024.

I, Hemanshu Upadhyay, Proprietor of M/s. HRU & Associates, Practicing Company Secretaries, have been appointed as a Scrutinizer by the Board of Directors of Pentokey Organy (India) Limited ("the Company") pursuant to section 108 of the companies Act, 2013 read with Rules made thereunder, as amended to scrutinize the electronic voting ("Remote e-voting") and the electronic voting process carried during the Annual General Meeting ("e-voting") for the resolution contained in the Notice convening the Thirty Seventh Annual General Meeting ("the Meeting/AGM") of the Members of the Company on Saturday, 28th September, 2024 held through Video Conferencing/ Other Audio Visual Means ("VC/OAVM") facility, submit my Consolidated report as under:

1. The Management of the Company is responsible for the compliance of provisions of the Companies Act, 2013 and the Rule made thereunder relating to Voting and in accordance with dated 08th April, 2020, dated 13th April, 2020, dated 05th May, 2020, 13th January, 2021, 14th December, 2021, 05th May, 2022, 28th December, 2022 and 25th September, 2023 (collectively referred to as "MCA Circulars") and the SEBI vide its circulars dated 12th May, 2020, 15th January, 2021, 13th May, 2022, 05th January, 2023 and 07th October, 2023 (collectively referred to as "Applicable Circulars") regarding holding of the AGM through Video Conferencing/ Other Audio Visual Means ("VC/OAVM") facility, without the physical presence of the Members of the company at the venue and my responsibility is only to the extent of making a Scrutinizer's Report for ascertaining the votes cast "in favour" or "against" for respective Resolution.



- 2. The Company had appointed Central Depository Services (India) Limited ("CDSL") for conducting the Remote e-voting prior to the AGM and for e-voting at the AGM.
- 3. The Remote e-Voting commenced on 9.00 a.m. (IST) on Wednesday, 25th September, 2024 and ended at 5.00 p.m. (IST) on Friday, 27th September, 2024.
- 4. The Members of the Company as on Saturday, 21st September, 2024, the "cut-off date" were entitled to vote on the resolutions stated in the Notice of the AGM of the Company.
- After the announcement of voting through e-voting at the AGM by the Chairman, the members of the Company who were present during the meeting through VC/OVAM and had not cast through Remote e-voting exercised the voting at the AGM.
- 6. After the closure of the AGM and closure of e-voting, the vote cast through e-voting during the AGM and through the remote e-voting prior to the AGM was unblocked at Mumbai from the website of CDSL i.e. https://www.evotingindia.com/
- 7. The Votes cast by Corporate/Institutional Members who have emailed the scanned certified true copy of the Board Resolution / Authority Letter etc to the company at cs@pentokey.com or to Datamatics Business Solutions Limited, Registrar and Share Transfer Agent at anand-bhilare@datamaticsbpm.com with a copy marked to evoting@cdsl.co.in and cs@pentokey.com have been considered valid.
