Please note that the Company has received a Combined Order on January 9, 2025 at 5:43 p.m. passed by the Commissioner of Income Tax (Appeals) – 54, Mumbai [CIT(A)] under Section 250 of the Income Tax Act, 1961 ("Act") disposing of appeals filed by the Company for Assessment Years (AY) 2012-13, 2015-16, 2016-17 and 2017-18. Vide this Combined Order, the CIT(A) has allowed all substantive grounds raised in the appeals filed by the Company against the assessment order passed under Section 143(3) of the Act for AY2016-17 and AY2017-18 and re-assessment order passed under Section 143(3) read with Section 147 of the Act for AY2012-13 and AY2015-16, respectively.

The brief details as required under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with SEBI Master Circular dated November 11, 2024 are enclosed herewith as an **Annexure 1**.
