China has put a hold on a proposal by the US and India at the United Nations to blacklist Abdul Rauf Azhar, the brother of Jaish-e Mohammed (JEM) chief Masood Azhar and a senior leader of the Pakistanbased terror organisation.

Abdul Rauf Azhar, born in 1974 in Pakistan, was sanc-

tioned by the US in December 2010.

On Wednesday, sources said China put a hold on a proposal by India and the US to designate Azhar as a global terrorist and subject him to assets freeze, travel ban and arms embargo.

This is the second time in less than two months that China has put a hold on a listing by the US and India to blacklist a Pakistan-based terrorist under the sanctions committee of the UN Security Council.

In June this year, China had put a hold, at the last moment, on a joint proposal by India and the US to list Pakistan-based terrorist Abdul Rehman Makki under the 1267 Al-Qaida Sanctions Committee of the UN Security Council.
